**With effect from 1 October 2015**

The General Board, on the recommendation of the Faculty Board of Economics, have approved an amendment to the title of a paper in Part IIA.

Regulation 16.

By amending the title of Paper 4 so as to read:

Paper 4. International trade and economic development

## Education Tripos

(*Statutes and Ordinances*, p. 319)

### With immediate effect

The General Board, on the recommendation of the Faculty Board of Education, have approved a correction to Schedule 1, governing subjects and papers in Section III of Part I of the Education Tripos, so as to align it with the regulations for Part I of the English Tripos for subjects in English, and English and Drama. The Schedule has been amended so as to remove the reference to ‘Practical criticism and critical practice’ (Paper 6 of Part I of the English Tripos (Old Regulations)) and to replace it with reference to ‘Practical criticism and critical practice’ (Paper 1 of Part I of the English Tripos (New Regulations)).

### SCHEDULE 1

#### SUBJECTS AND PAPERS FOR SECTION III OF PART I OF THE EDUCATION TRIPOS

*English*

*English and Drama*

By the addition of the following paper to the list of two or three papers that may be offered:

Practical criticism and critical practice (Paper 1 of Part I of the English Tripos (New Regulations))

And by removing the following paper:

Practical criticism and critical practice (Paper 6 of Part I of the English Tripos (Old Regulations))

The Faculty Board of Education are satisfied that no candidate’s preparation for the examination will be adversely affected.

## Education Tripos: Correction

(*Statutes and Ordinances*, p. 319)

### With effect from 1 October 2015

In the Notice amending the entry for Classics in Schedule 1, governing subjects and papers for Section III of Part I of the Education Tripos (*Reporter*, 6383, 2014–15, p. 486), the first sentence, as amended, should have read:

Candidates shall offer **the following two papers**:

Passages for translation from Latin authors (Paper 3 of Part IB of the Classical Tripos)

Latin literature (Paper 6 of Part IB of the Classical Tripos) (The examination requirements for this paper are set out in the regulations for Part IB of the Classical Tripos)

## Engineering Tripos, Parts IIA and IIB

(*Statutes and Ordinances*, p. 325)

### With effect from 1 October 2015

The General Board, on the recommendation of the Faculty Board of Engineering, have approved amendments to the regulations for the Tripos as follows: with the Faculty Board’s permission, to allow students to present themselves for honours in Part IIA in the year next but one after obtaining honours in Part IB, or to take Part IIB in the year next but one after obtaining honours in Part IIA; to produce class-lists for all of Part IIA and all of Part IIB, rather than for each engineering area; to allow the Part IIB class-list to be separated into three classes (Distinction, Merit, and Pass); to clarify that candidates spending terms studying at a certified institution shall be deemed to have kept those terms; and to remove the Technical University of Munich from the approved institutions for study exchange listed in the Schedule.

Regulation 15.

By inserting the following new sub-paragraph (b) and renumbering existing sub-paragraph (b) as (c):

- (b) a student who has obtained honours in Part IB of the Engineering Tripos, in the year next but one after so obtaining honours, provided that he or she presents a reasoned case to the Faculty Board by the division of the Easter Term of the year in which Part IB is taken;

## Regulation 22.

By amending the regulation so as to read:

**22.** The names of the candidates who obtain honours shall be arranged in three classes, the second of which shall be divided into two divisions. The names in the first and third classes and in each division of the second class shall be arranged in alphabetical order. For special excellence in Part IIA a mark of distinction may be awarded. A note shall be attached to the names of those candidates who qualify for each combination of subjects in Part IIA, announced by the Faculty Board under Regulation 16 as an engineering area.

## Regulation 23.

By inserting the following words ‘and to have kept those terms for the purpose of the regulations for Residence and Precincts of the University’ at the end of the first sentence.

By removing ‘Technical University of Munich’ from the Schedule of institutions approved for the purpose of Regulation 23 (Exchange Programmes).

## Regulation 24.

By inserting new sub-paragraph (c) so as to read:

(c) presents a reasoned case to the Faculty Board by the division of the Easter Term of the year in which Part IIA is taken, should he or she wish to proceed to Part IIB in the year next but one after obtaining honours in Part IIA;

## Regulation 31.

By amending the regulation so as to read:

**31.** The names of the candidates who obtain honours shall be arranged in alphabetical order within three classes: Distinction, Merit, and Pass. A note shall be attached to the names of those candidates who qualify for each combination of subjects in Part IIB, announced by the Faculty Board under Regulation 25 as an engineering area.

## Historical Tripos

(*Statutes and Ordinances*, p. 347)

### With effect from 1 October 2015

The General Board, on the recommendation of the Faculty Board for History, have approved an amendment to the scheme of examination for Part II of the Historical Tripos as follows:

## Regulation 16.

By removing the reference to Papers 23 and 24 in sub-section (vii), as these are permanently specified as falling mainly in the period after 1750.

## Human, Social, and Political Sciences Tripos

(*Statutes and Ordinances*, p. 355)

### With effect from 1 October 2015

The General Board, on the recommendation of the Faculty Board of Human, Social, and Political Science, have approved an amendment to the regulations so as to allow a change in title of four Archaeology papers.

## Regulation 15.

By amending the titles of Papers ARC18–21 so as to read:

- ARC18. Society and settlement in ancient Egypt<sup>1</sup>
- ARC19. Ancient Egypt in context: An archaeology of foreign relations<sup>2</sup>
- ARC20. The archaeology of religion in ancient Egypt<sup>1</sup>
- ARC21. The archaeology of death and burial in ancient Egypt<sup>2</sup>

## Law Tripos

(*Statutes and Ordinances*, p. 368)

### With effect from 1 October 2015

The General Board, on the recommendation of the Faculty Board of Law, have approved an amendment to Regulation 15 so as to move Paper 12 – *International law* from Group II to Group III.

## Manufacturing Engineering Tripos, Parts IIA and IIB

(*Statutes and Ordinances*, p. 375)

### With effect from 1 October 2015

The General Board, on the recommendation of the Faculty Board of Engineering, have approved amendments to the regulations for the Tripos as follows: with the Faculty Board's permission, to allow students to present themselves for honours in Part IIA in the year next but one after obtaining honours in Part IB of the Engineering Tripos; to clarify that candidates spending terms studying at a certified institution shall be deemed to have kept those terms; and to allow candidates on approved placements outside the University's Precincts to count terms towards residence.

Regulation 2.

By amending Regulation 2 so as to read:

**2.** The following may present themselves for honours in Part IIA:

(a) a student who has obtained honours in Part IB of the Engineering Tripos or in Part I of the Chemical Engineering Tripos may be a candidate for honours in Part IIA of the Manufacturing Engineering Tripos in the year after so obtaining honours;

(b) a student who has obtained honours in Part IB of the Engineering Tripos may be a candidate for honours in Part IIA of the Manufacturing Engineering Tripos in the year next but one after so obtaining honours, provided that he or she presents a reasoned case to the Faculty Board by the division of the Easter Term of the year in which Part IB is taken;

provided always that the student has kept seven terms and that twelve complete terms have not passed after her or his first term of residence.

Regulation 4.

By inserting the following words 'and to have kept those terms for the purpose of the regulations for Residence and Precincts of the University' at the end of the first sentence.

Regulation 5.

By inserting new Regulation 5 as follows and renumbering the remaining regulations:

**5.** Attendance by candidates for the Part IIB examination on placements outside the University precincts, under arrangements approved by the Faculty Board of Engineering, shall count towards the keeping of terms for the purpose of the regulations for Residence and Precincts of the University.

## Modern and Medieval Languages Tripos

(*Statutes and Ordinances*, p. 385)

### With immediate effect

The General Board, on the recommendation of the Faculty Board of Modern and Medieval Languages, have approved an amendment to Regulation 18(b) so as to allow for the addition of Modern Greek as one of the languages in which papers may be set in Parts IB and II, as specified in Schedule B.

Regulation 18.

By amending the regulation so as to read:

(b) In Part IB and Part II papers shall be set in Modern Greek, in Neo-Latin, in linguistics, in Catalan, Dutch, Polish, and Ukrainian, in Ibero-Lusophone studies, and in comparative studies, as specified in Schedule B.

The Faculty Board of Modern and Medieval Languages have confirmed that no candidate's preparation for the examination will be affected.

## Natural Sciences Tripos

(*Statutes and Ordinances*, p. 405)

### With effect from 1 October 2015

The General Board, on the recommendation of the Natural Sciences Tripos Management Committee, have approved an amendment to the regulations regarding eligibility for Part IA and to clarify the wording regarding eligibility for Part Ib and Part II.

#### Regulation 2.

By deleting sub-paragraph (b) and amending the regulation so as to read:

2. A student who has not obtained honours in another Honours Examination may present him- or herself as a candidate for honours in Part IA, provided that he or she has kept one term and that three complete terms have not passed after her or his first term of residence.

#### Regulation 3.

By replacing the term 'another Honours Examination' with 'an Honours Examination'.

#### Regulation 4.

By amending the regulation so as to read (retaining footnotes):

A student who not earlier than the fourth term after her or his first term of residence has obtained honours in an Honours Examination other than Part IA of the Natural Sciences Tripos or Part IA of the Medical and Veterinary Sciences Tripos, may be a candidate for honours in Part II in the year next after so obtaining honours; provided that the student has kept seven terms and that twelve complete terms have not passed after her or his first term of residence.

## Examination in Computational Biology for the M.Phil. Degree

(*Statutes and Ordinances*, p. 521)

### With effect from 1 October 2015

The General Board, on the recommendation of the Degree Committee for the Faculty of Mathematics, have approved the following amendments to the regulations: to allow the Degree Committee power to announce additional optional modules no later than the beginning of Michaelmas Term; to revise the number of modules from nine to eight, including half modules; and to reflect the requirement of an additional two-hour examination.

#### Regulation 1.

By amending the regulation so as to read:

1. The Degree Committee for the Faculty of Mathematics shall publish, not later than the end of the Easter Term each year, a list of mandatory and optional modules for the examination to be held in the academic year next following, provided that the Degree Committee shall have power to give notice of additional optional modules not later than the beginning of the Michaelmas Term preceding the examination. In publishing the list the Degree Committee shall announce the method of examination of each module, which may include a written examination, a long essay, shorter essays, project work, or a combination of these; they shall specify the limits to be placed on the length of any essays and project work.

#### Regulation 2.

By amending sub-paragraph (a), introducing new sub-paragraph (b), and renumbering existing (b) as (c) so as to read:

2. Each candidate shall offer:
  - (a) the written examinations or other assessment specified for a total of eight modules, inclusive of half modules, chosen from the list published under Regulation 1;
  - (b) a written examination of two hours' duration addressing the material taught under Regulation 1;
  - (c) a report of not more than 18,000 words in length and an oral presentation based on a laboratory project carried out by the candidate in one or more institutions approved by the Degree Committee.

## **Examination in Developmental Biology for the M.Phil. Degree**

*(Statutes and Ordinances, p. 524)*

### **With effect from 1 October 2015**

The General Board, on the recommendation of the Degree Committee for the Faculty of Biology, have given permission for the amendment of the regulations to remove the requirement for candidates to undertake practical work.

By deleting Regulation 2 and renumbering the remaining regulation.

## **Examination in Screen Media and Cultures for the M.Phil. Degree**

*(Statutes and Ordinances, p. 545)*

### **With effect from 1 October 2016**

The General Board, on the recommendation of the Faculty Board of Modern and Medieval Languages, have approved the retitling of the above course of study for the M.Phil. Degree to 'Film and Screen Studies'.

The programme specification and regulations are otherwise unchanged.

## Examination in Clinical Medicine for the M.St. Degree

### With effect from 1 October 2016

The General Board, on the recommendation of the Faculty Board of Clinical Medicine and the Strategic Committee of the Institute of Continuing Education, have approved Clinical Medicine as a subject for the Master of Studies Degree with effect from 1 October 2016. Special regulations for the examination in the subject have been approved as follows:

CLINICAL MEDICINE

1. The scheme of examination for the course of study in Clinical Medicine for the degree of Master of Studies shall consist of:

(a) three core modules, *clinical research*, *clinical education*, and *clinical leadership*, which will be examined by assignments of 3,000 words, or assignments deemed their equivalent by the Degree Committee for the Faculties of Clinical Medicine and Veterinary Medicine, except where other methods of assessment are published in individual module descriptions;

and

(b) course-work and self-directed learning as announced by the Degree Committee not later than the end of the Easter Term preceding the examination;

and

(c) three essays which shall be examined by assignments of 2,000 words, or assignments deemed their equivalent by the Degree Committee on set topics falling within a field approved by the Degree Committee;

and

(d) a thesis, of not more than 10,000 words in length, or an assignment deemed its equivalent by the Degree Committee, including footnotes and appendices but excluding bibliography, on a subject approved by the Degree Committee.

2. Each candidate shall pursue the examination in one of the themes approved from time to time by the General Board on the recommendation of the Degree Committee and specified in the Schedule to these regulations.

3. At the discretion of the Examiners the examination shall include an oral examination on the thesis and on the general field of knowledge within which it falls; such an oral may include questions relating to one or more of the other pieces of work submitted by the candidate under Regulation 1.

4. The Examiners may recommend to the Degree Committee that it recommends to the Strategic Committee of the Institute of Continuing Education the award of the Postgraduate Certificate to a candidate who has satisfactorily completed the three core modules specified in Regulation 1(a) but has not completed, or fails to reach the required standard in, the work required under Regulation 1(b), 1(c), and 1(d).

## SUPPLEMENTARY REGULATIONS

(*Statutes and Ordinances*, p. 264)

**With effect from 1 October 2015**

The Faculty Board of History give notice of an amendment to the supplementary regulations for the Preliminary Examination for Part I of the Historical Tripos. Paper 3 will be set in two sections.

By amending the regulation on Papers 2–19 so as to read:

*Papers 2–19. British, European, and world history*

The scope of Papers 2–18 shall be that of the corresponding papers in Part I of the Tripos. The scope of Paper 19 shall be that of Papers 21 and 23 in Part I.

Three questions must be answered but no question shall be specified as compulsory, except that in Paper 3 (British political history, 1050–1509), Paper 4 (British political history, 1485–1714), and Paper 18 (European history, since 1890), candidates will be required to answer at least one question from each of sections A and B.

## SUPPLEMENTARY REGULATIONS

(*Statutes and Ordinances*, p. 316)

**With effect from 1 October 2015**

The Faculty Board of Economics give notice of amendments to the supplementary regulations for the following papers. The supplementary regulations for other papers remain unchanged.

## PART I

*Paper 1. Microeconomics*

This paper will deal with the following: decision theory; the theory of the consumer: choice and demand; the theory of the producer: costs and supply; supply, demand, and market equilibrium; partial and general equilibrium analysis; demand and supply in factor markets; market failure and the role of the state; welfare economics.

## PART IIA

*Paper 1. Microeconomic principles*

The paper covers the following topics in economic theory: consumer theory; producer theory; general equilibrium theory; welfare economics; introduction to decision-making under uncertainty; asymmetric information; and contract theory.

*Paper 4. International trade and economic development*

The paper provides a theoretical and practical introduction to two major topics that are inter-related: international trade and economic development. The course introduces concepts and theories in development economics and provides a broad overview of the key models and issues in development economics. It uses tools from both macro- and microeconomics to examine topics ranging from the political economy of development, economic growth and measurement of well-being, imperfections of markets, and the role of institutions. The course also covers the theoretical models of international trade, global production structures, and associated policies. It constitutes a self-contained one-year course for those interested in these fields but not planning to pursue them further.

*Paper 6. Mathematics and statistics for economists*

The paper covers those aspects of linear algebra, differential and integral calculus, differential and difference equations, probability theory, and statistical theory that are used in various parts of the Tripos. This paper is recommended for those who plan to take Paper 6 (Banking, money, and finance) of Part IIB of the Economics Tripos.

*Paper 7. Labour*

The paper has the following subject matter: the distribution of wages and the determination of employment by household supply and employer demand for labour, the role of market frictions in shaping the equilibrium outcome, human capital and education, migration, asymmetric information and screening, theories of compensating differentials, performance pay, labour mobility, and discrimination. Candidates will be expected to know the main empirical data sources on the labour market and they should be familiar with the modern approaches to the analysis of such data. Students will be introduced to empirical work on these issues in country-specific contexts and will learn about country-specific peculiarities among advanced economies regarding, for example, wage dispersion, minimum wages, CEO compensation, gender wage differentials, social values, discrimination, pension systems, unemployment insurance, and employment protection. They should be able to draw selectively on contributions from sociology and political science.

## PART IIB

*Paper 7. Public economics*

The paper studies the following subject matter: optimal taxation, externalities and environmental policy; social security; political decision-making and political economics; public expenditure and tax systems in practice. The paper will require knowledge of the relevant theories supporting empirical evidence and institutions.

*Paper 14. A subject in economic history*

This paper will, until further notice, be a paper entitled 'World Depression in the interwar years'. Its main focus will be on the causes and courses of the Great Depression of the 1930s, but the events of the 1920s including the inflation and deflation of 1919–21 will also receive attention. Topics covered will include business cycles, the causes and effects of financial crises, the transfer problem, international monetary arrangements, the growth of protection and the development of trading blocs, the agrarian depression, and the comparative experience of different countries with regard to unemployment. The main countries considered will be Britain, France, Japan, Germany, and the USA, but the paper will not be exclusively confined to these.

**Geographical Tripos, Parts IB and II, 2016**

The Faculty Board for Earth Sciences and Geography give notice that, for the examination for Part IB and Part II of the Geographical Tripos to be held in 2016, the papers to be offered will be examined as shown in the tables below.

In these tables, the following terms are defined:

1. **'Two+1 examination'**: The assessment of such papers will consist of a conventional two-hour examination in which candidates will be asked to attempt two questions from a choice of not fewer than six questions. The papers will be undivided. In addition, there will be assessed course-work to be submitted not later than the division of the Easter Term in the year of the examination. The nature of the course-work required will be determined by the University Teaching Officer responsible for the co-ordination of the course, who will provide written details of the procedures which will be followed. The course-work will be equivalent to one question in quantity and for assessment in determining an overall mark for the paper.
2. **'Three-hour examination'**: The papers will be examined by a conventional unseen three-hour examination in which candidates will be asked to attempt three questions from a choice of not fewer than nine questions. The papers will be undivided.

In these papers candidates will be required to show knowledge of political aspects and also of general aspects of English, Irish, Scottish, and Welsh history where relevant to the period studied. Candidates will be expected to show evidence of their ability to use and interpret contemporary documents. In each paper three questions must be answered, but no question shall be specified as compulsory, except that in Paper 3 (British political history, 1050–1509) and Paper 4 (British political history, 1485–1714) candidates will be required to answer at least one question from each of sections A and B.

## Music Tripos, 2015–16

Each module for this course is assessed by no more than two or three course-work assignments, each involving an element of computational or theoretical work. The expected maximum submission length for each piece of work is twenty pages, excluding any appendices.

In addition to the offered modules, students sit a two-hour general examination in the Easter Term on the material taught within the modules.

Students are also required to complete an internship project which is assessed by a report of no more than 18,000 words and a presentation.

The weighting for the examination in Computational Biology is out of 12, divided as follows: each module is weighted at 1, and half modules at 0.5, meaning a total weighting of 8 for the modules. The general examination is weighted at 1. The internship project is weighted at a total of 3, with 2.5 for the report and 0.5 for the presentation.

## REPORTS

### Report of the Council on the construction of education space and gallery refurbishment at Kettle's Yard

The COUNCIL begs leave to report to the University as follows:

1. In this Report the Council is seeking approval for the construction of a new education wing and a major gallery refurbishment at Kettle's Yard as set out below.

2. A First-stage Report on the construction of education space and gallery refurbishment at Kettle's Yard was submitted to the Regent House on 8 October 2014 (*Reporter*, 6359, 2014–15, p. 41) and approved by Grace 1 of 5 November 2014. This Second-stage Report is to inform the Regent House about further development of the scheme and to seek approval for construction to proceed.

3. The project will develop vacant premises at Nos. 4 and 5 Castle Street to provide two education spaces, one at basement level for practical art activities, and the other at second-floor level for lectures, films, seminars, etc. The existing gallery spaces will be reconfigured to create two contemporary galleries. Gallery 1 (situated along Castle Street) will utilize the existing flat above to create a double height gallery. The existing flat on the second floor will be adapted to become the new office and meeting room for Kettle's Yard. The existing office space will become a small café and the existing education space will become the new shop. The existing floor level of this space will be raised to match the floor level of the entrance space, where a welcome desk will be situated. A new glazed screen is proposed to provide one point of entrance and exit from the courtyard.

4. The project will be carried out in one phase and will create 454m<sup>2</sup> of new accommodation and will reconfigure

634m<sup>2</sup> of existing accommodation. The Kettle's Yard site at Castle Street will close temporarily from 22 June 2015 for the redevelopment works. Plans are in place for some Kettle's Yard activities and projects to continue off-site for the duration of the closure. The project is planned to be completed so that the Kettle's Yard site reopens to the public by October 2017.

5. The estimated project cost is £8.069m. This includes a sum of £756k spent on enabling works, archaeological surveys, and professional fees associated with an earlier project to create an education wing at Kettle's Yard, which was approved by the University in 2010. Those works were nonetheless essential for the implementation of the current project. Arts Council England has agreed to provide funding of £3.5m, and the Heritage Lottery Fund has made an award of £1,969,702. The balance of the funding has been raised primarily from Trusts and Foundations.

6. The Planning and Resources Committee, at their meeting on 25 June 2014, approved the Full Case for the proposed development, subject to a successful bid to Arts Council England. The increase in running costs for the extended facilities has been incorporated into the business plan and funds have been raised, in addition to the capital requirements, to create an endowment to cover these additional recurrent costs.

7. Drawings of the proposed scheme are displayed for the information of the University in the Schools Arcade. A site plan is shown below.

#### 8. The Council recommends:

I. That approval is confirmed for the construction of education space and gallery refurbishment at Kettle's Yard as set out in this Report.

II. That the Pro-Vice-Chancellor (Planning and Resources) be authorized to accept a tender for the works, within the available funding, in due course.


