REGULATIONS FOR EXAMINATIONS

Examination in Applied Biological Anthropology for the M.Phil. Degree

(*Statutes and Ordinances*, p. 479)

With immediate effect

The General Board has, on the recommendation of the Degree Committee for the Faculty of Human, Social, and Political Science, approved an amendment to the regulations so as to remove reference to option courses and bring the regulations into line with information provided to students in the Course Handbook.

By amending Regulation 1(d) so as to read ‘two written assignments as prescribed by the Degree Committee (which may take the form of an essay, article, or laboratory report).’

Natural Sciences Tripos, Part II (Biological and Biomedical Sciences), 2016–17

The Faculty Board of Biology gives notice, in accordance with Regulation 30 for the Natural Sciences Tripos, that the following combinations of Major and Minor Subjects will be offered in the Natural Sciences Tripos, Part II (Biological and Biomedical Sciences) in 2016–17.

Further to the Notices published on 11 November 2015 (*Reporter*, 6403, 2015–16, p. 120), and 3 February 2016 (*Reporter*, 6413, 2015–16, p. 345) the Faculty Board of Asian and Middle Eastern Studies gives notice that, with effect from the examination to be held in 2016, the form of the examination for the following paper for Part II of the Tripos will be as specified below:

X.9. Judaism II (Paper C.8 of the Theological and Religious Studies Tripos)

The examination for this paper will consist of a three-hour written paper which will be divided into two sections, A and B, corresponding to the set topics. Section A will consist of at least three questions. Each question will consist of an unseen selection drawn from primary texts of classical rabbinic literature; candidates must provide a written commentary on any one of these, based on text-analysis skills developed in the classes, lectures, and supervisions. Section B will contain at least eight essay-style questions on the topic of Jewish Law. Candidates will be required to attempt two questions from section B.

No candidate's preparation for the examination in 2016 will be affected.

Theological and Religious Studies Tripos, Part IIB, 2016: Correction

Further to the Notices published on 11 November 2015 (*Reporter*, 6403, 2015–16, p. 123), and 3 February 2016 (*Reporter*, 6413, 2015–16, p. 345) the Faculty Board of Divinity gives notice that, with effect from the examination to be held in 2016, the form of the examination for the following paper for Part IIB of the Tripos will be as specified below:

GROUP C

Paper C8. Judaism II (also serves as Paper X.9 of the Asian and Middle Eastern Studies Tripos)

The examination for this paper will consist of a three-hour written paper which will be divided into two sections, A and B, corresponding to the set topics. Section A will consist of at least three questions. Each question will consist of an unseen selection drawn from primary texts of classical rabbinic literature; candidates must provide a written commentary on any one of these, based on text-analysis skills developed in the classes, lectures, and supervisions. Section B will contain at least eight essay-style questions on the topic of Jewish Law. Candidates will be required to attempt two questions from section B.

No candidate's preparation for the examination in 2016 will be affected.

REPORTS

Report of the Council on the arrangements for approving market pay

The COUNCIL begs leave to report to the University as follows:

1. In this Report the Council is seeking approval for amendments to the arrangements for approving market pay that were established by Grace 2 of 22 May 2013 approving the recommendations of the *Joint Report of the Council and the General Board on amendments to the pay and grading scheme for non-clinical staff implemented following the Second Joint Report of 25 July 2005* (*Reporter*, 6302, 2012–13, p. 423).

2. Market pay was introduced for recruitment and retention purposes, replacing the award of market supplements with effect from 1 January 2014. Under the current procedure for market pay awards,¹ the HR Committee, or for professorial or equivalent staff the Remuneration Committee of the Council, must approve an award 'where the market pay exceeds 10% of the lowest salary point of the grade (or in the case of grade 12, the lowest salary point of the relevant band)', in addition to the approval of the relevant officers. In most cases where it is necessary to agree market pay for recruitment or retention purposes, immediate action is usually required and further committee approval militates against timely action.

3. The Council, on the recommendation of the Remuneration Committee and with the support of the Pro-Vice-Chancellor (Institutional and International Relations) in her capacity as Chair of the HR Committee, proposes that the threshold for requiring committee approval for an award of market pay be raised to 50% or £50k (whichever is the smaller) of basic pay, i.e. in the third bullet point in paragraph 6.4 of the Joint Report, replace '10%' with '50% or £50k (whichever is the smaller)'.¹

4. The Council publishes statistical information annually about staff grades, additional payments, and market supplements; Tables 11(b) and (d) provide, respectively, data on market pay awards currently being paid and those newly awarded in the last year. The format of the data provided on market pay awards will be reviewed before the Notice concerning data as at 31 July 2016 is published.

5. The Council notes that the HR Committee is conducting a wide-ranging review of certain HR practices including pay and reward, for report to the Council later in 2015–16.

6. The Council recommends:

I. That, with effect from 10 April 2016, the revised arrangements for approving market pay as set out in paragraph 3 of this Report be approved.
