# Statutes approved

5 August 2022

The Registrary has received notice from the Clerk of the Privy Council that Her Majesty the Queen, at a Council held on 19 July 2022, was pleased to approve the following changes to the University's Statutes.

- The amendments to Statutes B I 2 and B III 4 confirm that a decision of a body granted authority in the University's
  Ordinances to assess capability to study may deprive a person of membership of the University, and were approved
  by Grace 8 of 29 July 2020.
- The amendment to Statute C XI 2 removes a requirement to publish a Report to establish a Professorship, and was approved by Grace 3 of 8 December 2021.
- The amendments to Statute D II 2, 10, 11, 12 and 15 confirm that the falsification of awards by formerly registered students is within the jurisdiction of the student disciplinary panels and revise the terminology used in relation to student discipline, and were approved by Grace 1 of 30 May 2019 following a ballot.

# **Election to the Council**

No other candidates having been nominated, Baroness Morgan is duly elected to serve as a member of the Council in class (a) with immediate effect until 31 December 2024.

# University salaries and stipends

The Universities and Colleges Employers Association (UCEA) has proposed a pay settlement from 1 August 2022. The settlement provides for a 3.0% increase to the stipends and salaries of non-clinical staff on all spine points, except spine points 15 to 31 where the increases will be as follows:

It should be noted that the New Joint Negotiating Committee for Higher Education Staff (New JNCHES) trade unions remain in dispute over the offer. However, UCEA has confirmed that the formal dispute resolution procedure set out in the New JNCHES agreement has been exhausted and has therefore advised that implementation of the pay settlement should proceed.

The stipends and salaries of certain University staff require the approval of the Regent House. The Council is accordingly submitting a Grace (Grace 1, p. 710) to the Regent House for the approval of an increase of 3.0% to 9.0% (as specified above) in these stipends and salaries. An updated Cambridge general stipend and salary scale, showing the proposed new stipends and salaries for each grade, is included in this Notice. This indicates the 49 points of the national single spine as well as those points, above and below, which are extensions to the spine in Cambridge. Changes will also be applied to associated payments directly linked to a single spine stipend/salary point.

Subject to the approval of this Grace, the corresponding increases will be implemented in the stipends of those offices which do not require the approval of the University as well as in the salaries of analogous unestablished staff.

It is expected that, if the Grace is approved, the increases will be paid to staff in the September 2022 payroll.

Notes to the University of Cambridge Single Salary Spine

Note 1:	An asterisk (*) denotes a contribution point and progress through these is awarded on merit.
Note 2:	Grade T is for staff who are studying for an approved qualification or undergoing 'in-service' training. Points 1–10 of Grade T are no longer in use.
Note 3:	On 1 January 2010 the first contribution points of Grades 2, 3 and 4 became service points and on 1 January 2015 the first contribution points of Grades 1, 5 and 6 became service points.
Note 4:	Assistant Professors and Associate Professors (Grade 9) will be appointed to Grade 9; Associate Professors (Grade 10) will be appointed to Grade 10.  Assistant Professors and Associate Professors (Grade 9) may progress through service points 1–9 of Grade 9.  Associate Professors (Grade 10) may progress through service points 1–3 and contribution points 4–5 of Grade 10.  Professors (Grade 11) will only be appointed to point 2 in Grade 11 (point 63).  Senior Research Associates will be appointed to Grade 9.  Research Associates will be appointed to Grade 7 spine point 40 from 6 April 2017 and to spine point 41 from 1 October 2017.  Research Assistants will be appointed to Grade 5.  The contribution points in Grade 9 do not apply to Assistant Professors or Associate Professors (Grade 9) and likewise the contribution points in Grade 11 do not apply to Professors (Grade 11). They apply to academic-related staff.  The minimum for Professors (Grade 12) will be point 68 in band 1 of Grade 12.
Note 5:	For academic staff (other than Professors (Grade 12)) contribution will be recognised through the promotions procedure as now and not by use of contribution points.  Associate Professors (Grade 10) will also have access to the Academic Career Pathways scheme under which they may also be awarded contribution points 4–5 in Grade 10.
Note 6:	Academic-related professorial-equivalent staff will be appointed on the contribution bands of Grade 12 according to the HERA points boundaries for each level.
Note 7:	Specific arrangements will apply to progression in service-related points on some grades in compliance with the Memorandum of Understanding.
Note 8:	Incremental progression through the service-related points occurs on the incremental date which will normally be on the anniversary of appointment or 1 April, 1 July or 1 October respectively for staff engaged on terms and conditions for Manual, Clerical/Secretarial, and Technical Division appointments.
Note 9:	Points 32 and 50 were aligned to the National Single Pay Spine for Higher Education Academic and Support Staff, as negotiated by the Universities and Colleges Employers Association on behalf of UK higher education employers, with effect from 1 January 2014.
Note 10:	Spine points 13 and 14 have been removed from the National Spine and the University's Grade 1 with effect, for point 13, from 1 August 2016 and, for point 14, from 1 August 2022.
Note 11:	Direct employees of the University appointed to Grade 1 will not be paid below spine point 20, with effect from 1 January 2022.

# NOTICES BY THE GENERAL BOARD

# **Directors and Assistant Directors of Studies in General Practice**

25 July 2022

The General Board, on the recommendation of the Faculty Board of Clinical Medicine, has amended the Regulations governing the appointment of Directors and Assistant Directors of Studies in General Practice in the Faculty of Clinical Medicine. The changes noted below have been made in order to bring the post of Director of Studies in General Practice into closer alignment with the arrangements already in place for the appointment of the Clinical Dean. The role of Director of Studies in General Practice has changed significantly over the last few years. This is due to a rise in clinical student numbers since 2017 (numbers are now at steady state), as well as to curricular changes. There has been an increase in the number of weeks of General Practice teaching within the clinical curriculum, and also in the range of material taught in General Practice. Due to the nature of the spiral curriculum, there are a range of specialties in which students are introduced to material first in the context of primary care, and subsequently in the context of longer placements in secondary care. These changes (in both student numbers and the curriculum) have meant that the role of Director of Studies in General Practice has evolved significantly and the School wishes to ensure that the role can be held as a full-time permanent appointment, subject to confirmation of probation, rather than as a rotating appointment.

General Board Regulations for Directors and Assistant Directors of Studies in General Practice (*Statutes and Ordinances*, p. 637): By replacing Regulations 1–3 with the following new Regulations 1–5 and renumbering existing Regulation 4 as 6:

- 1. There shall be a University office of Director of Studies in General Practice, and any such number of University offices of Assistant Director of Studies in General Practice as the General Board may from time to time determine on the recommendation of the Faculty Board of Clinical Medicine.
- **2.** Appointment to the University office of Director of Studies in General Practice shall be made by a Selection Committee constituted under Special Ordinance C (x). Appointment shall be subject to the satisfactory completion of a three-year period of probation, unless the waiver of this requirement is recommended by the Selection Committee and approved by the Head of the School.

- **3.** On confirmation of appointment, the Director of Studies in General Practice shall hold office, subject to the provisions of Statute C or any Special Ordinance made under it, until the retiring age, so long as the person appointed satisfactorily performs the duties of the office.
- **4.** The Council of the School of Clinical Medicine shall have power to direct, either of its own motion or on the recommendation of the Faculty Board, comparable authority, or Selection Committee concerned, that appointment to the University office of Director of Studies in General Practice shall be for a fixed term, which may be shorter than the period specified in Regulation 3 above.
- **5.** Appointments and reappointments to a University office of Assistant Director of Studies in General Practice shall be made by a Selection Committee constituted under Special Ordinance C (x), for periods not exceeding three years at a time.

# Academic Career Pathways (Research and Teaching) 2022 exercise: Appointments and titles

In its Report, dated 15 June 2022, on the Academic Career Pathways (Research and Teaching) 2022 exercise, (*Reporter*, 6662, 2021–22 p. 549), the General Board recommended the establishment of 68 Professorships (Grade 12) and 100 Professorships (Grade 11). #### REGULATIONS FOR EXAMINATIONS

# **Architecture Tripos**

(Statutes and Ordinances, p. 280)

#### With effect from 1 October 2021

The General Board, on the recommendation of the Faculty Board of History of Art and Architecture, has approved amendments to the Architecture Tripos with effect from 1 October 2021. The changes aim to improve the student experience by replacing traditional examinations with coursework and formalising the reassessment process required for professional accreditation. They take on board comments from students and those who teach them. Although the regulations have been rewritten for clarity and brevity, the substance of the course remains the same.

#### Regulation 1.

By amending the second sentence to read 'There shall be a separate class-list for each Part.'

Regulations 2(a) and (b) and 4(a).

By replacing 'her or his' with 'the student's'.

Regulations 6 and 9.

By deleting existing Regulations 6 and 9 and renumbering the remaining regulations.

Regulation 8.

By deleting the last sentence of existing Regulation 8 (renumbered 7).

Regulation 11 (renumbered 9) and new Regulations 10 and 11.

By amending existing Regulation 11 (renumbered 9) and inserting new Regulations 10 and 11, to read as follows:

- [9.] The Faculty Board shall publish changes to the titles of papers, subjects, special periods and books prescribed under the following regulations for Parts IA, IB and II of the Tripos not later than the end of Easter Term next preceding the examination to which they apply; provided that the Board shall have the power of subsequently issuing amendments if it has due reason for doing so and if it is satisfied that no student's preparation for the examination is adversely affected.
- [10.] The Faculty Board shall publish the dates for submission of studio-work in all Parts not later than the beginning of the Full Michaelmas Term next preceding the examination. The Department shall issue detailed instructions concerning the studio-work not later than the division of the Michaelmas Term next preceding the examination.
- [11.] In all Parts the teachers under whose direction the work was performed shall present to the Examiners detailed reports on the performance of each candidate in the coursework. The Faculty Board shall publish the form and conduct of the coursework for each paper by the not later than the beginning of the Full Michaelmas Term next preceding the examination.

Regulations 12-18.

By amending the existing regulations to read as follows:

# PART IA

- 12. The examination for Part IA of the Architecture Tripos shall consist of two sections:
- Section A. Studio-work.
- Section B. Five papers as follows:
  - Paper 1. Introduction to the history and theory of architecture to 1800.
  - Paper 2. Introduction to the history and theory of architecture after 1800.
  - Paper 3. Fundamental principles of construction.
  - Paper 4. Fundamental principles of structural design.
  - Paper 5. Fundamental principles of environmental design.
- 13. A candidate for Part IA shall be required:
- (a) for Section A, to present to the Examiners a portfolio of studio-work carried out during the current academic year.
- (b) to offer all five papers in Section B. All five papers shall be examined by coursework.

#### PART IB

- 14. The examination for Part IB of the Architecture Tripos shall consist of two sections:
- Section A. Studio-work.
- Section B. Five papers as follows:
  - Paper 1. Studies in the history and theory of architecture I.
  - Paper 2 Studies in the history and theory of architecture II.
  - Paper 3 Principles of construction.
  - Paper 4 Principles of structural design.
  - Paper 5 Principles of environmental design.
- 15. A candidate for Part IB shall be required:
- (a) for Section A, to present to the Examiners a portfolio of studio-work carried out during the current academic year;
- (b) for Section B, to offer all five papers. All five papers shall be examined by coursework.

# PART II

- **16.** The examination for Part II of the Architecture Tripos shall consist of three sections:
- Section A. Studio-work.
- Section B. Four papers as follows:
  - Paper 1. Advanced studies in the history and theory of architecture.
  - Paper 2 Management, practice and law.
  - Paper 3 Advanced studies in structural analysis, constructional technology and environmental design related to case studies.
  - Paper 4 Architectural engineering.
- Section C. A dissertation, or an alternative exercise of equivalent scope and standard approved by the Faculty Board, on a subject approved by the Faculty Board.
- 17. A candidate for Part IB shall be required:
- (a) for Section A, to present to the Examiners a portfolio of studio-work carried out during the current academic year;
- (b) for Section B, to offer all four papers. All four papers shall be examined by coursework;
- (c) for Section C, to submit a dissertation, or an alternative exercise of equivalent scope and standard, in accordance with the provisions of Regulations 18 and 19.

Regulations 18-19.

By replacing 'thesis' with 'dissertation'.

Regulation 18(a).

By removing the words 'by notice in the Department of Architecture'.

Regulation 18(b).

By replacing the words 'Each candidate shall submit the proposed subject of his or her thesis' with 'Candidates shall submit the proposed subject of their dissertation'.

Regulation 18(d).

By amending the regulation to read as follows:

(d) The Secretary of the Faculty Board shall notify the Examiners of the subjects approved for candidates' dissertations and exercises under Regulation 18(c). Having considered these subjects, the Examiners shall have power to impose restrictions on the questions that a candidate may offer in Paper 1, and shall inform candidates of any such restrictions not later than the end of the first quarter of the Easter Term.

Regulation 19.

In the first sentence, by replacing 'notes, appendices' with 'notes and appendices'.

And in the third sentence, by replacing 'Each candidate will be required to sign a declaration that the thesis is his or her own work' with 'Candidates shall be required to sign a declaration that the dissertation is their own work'.

Regulation 20.

By amending the regulation to read as follows:

**20.** If at the first attempt a candidate in any Part fails to satisfy the Examiners in one or more components of examination which are required for professional accreditation but achieves marks overall that would otherwise qualify them for honours in that Part, the candidate shall at the discretion of the Examiners be eligible for re-examination in the relevant component or components under conditions set by the Faculty Board, taking those components separately or together. Re-examination shall not affect the mark in that Part, which will remain unchanged.
