# **Economics Tripos, Part IIB**

## SUPPLEMENTARY REGULATIONS

(Statutes and Ordinances, p. 304)

## With effect from 1 October 2012

The Faculty Board of Economics give notice that they have amended the detail for certain papers as follows:

Paper 10. Theory and practice of econometrics II

By amending the detail so as to read:

This paper develops and extends the econometric techniques beyond those covered in Paper 3 in Part IIA. It will involve discussion of the empirical application of these techniques to economic problems using examples from the econometric literature. Technical derivations will be kept to a minimum. The examination for this paper consists of a written paper of three hours' duration.

Paper 17. A subject in the field of sociology and politics

# Modern and Medieval Languages Tripos

(Statutes and Ordinances, p. 356)

#### With effect from 1 October 2012

The regulations for Parts IA, IB, and II of the Tripos have been amended. Certain papers in Modern Greek will be available at Part II during the academic year 2012–13; all papers in Modern Greek specified in Schedule A will be suspended until further notice thereafter (see *Reporter*, 2008–09, p. 657). Papers in French have been revised and restructured across Parts IB and II in order that a clear menu of papers is available at Part IB that acts as a feeder into Part II. The titles and lists of other papers in German, Italian, Portuguese, Russian, Spanish, and Linguistics available to candidates under Schedules IA, IB, and II have also been amended.

#### Regulation 18(a).

Candidates for Part II in 2013, who have previously taken Part I of the Historical Tripos and who did not offer in that Part a paper falling mainly in the period before 1750, may meet the requirement to take a pre-1750 paper in Part II by offering one of the Special Subjects B, C, E, and F or by offering Paper 3 or one of the Papers 6, 7, 8, 9, 11, 14, and 15 or a dissertation, provided that its subject falls mainly in the period before 1750.

Candidates for Part II in 2013, who have previously taken Part I of the Historical Tripos and who did not offer in that Part a paper falling mainly in the period after 1750, may meet the requirement to take a post-1750 paper in Part II by offering one of the Special Subjects G, H, I, J, K, O, and Q or by offering Papers 4 or 5 or one of the Papers 19, 21, 22, 24, 25, 28, 29, and 30 or a dissertation, provided that its subject falls mainly in the period after 1750.

Candidates for Part II in 2013, who have previously taken Part I of the Historical Tripos and who did not offer in that Part a paper in European History, may meet the requirement to take a European History paper in Part II by offering one of the following papers: 7, 8, 9, 14, 21, 22, and 25.

The Faculty Board are satisfied that no candidate's preparation for examination will be adversely affected by these amendments.

#### FORM AND CONDUCT OF EXAMINATIONS, 2011-12

Notices by Faculty Boards, or other bodies concerned, of changes to the form and conduct of certain examinations to be held in 2011–12, by comparison with those examinations in 2011, are published below. # Politics, Psychology, and Sociology Tripos

PART I

The Faculty Board of Human, Social, and Political Science give notice that, with effect from the examinations to be held in 2012, the form of the examination for the following paper for Part I of the Politics, Psychology, and Sociology Tripos will be as specified below:

#### Section A

Paper 1. Analysis of politics I

The questions in the first section of the examination paper will no longer be passages from texts. 'Principles of politics applicable to all representative governments' is now a set text for Constant. Gandhi's *Hind Swaraj* has replaced Kant's 'Perpetual Peace'. A sample examination paper is available on the Faculty website.

All other papers remain unchanged.

PARTS IIA AND IIB

The Faculty Board of Human, Social, and Political Science give notice that, with effect from the examination to be held in 2012, the form of the examination for the following papers for Parts IIA and IIB of the Politics, Psychology, and Sociology Tripos will be as specified below:

#### **Politics and International Studies**

Pol 3. The analysis of modern politics II: Ethics and world politics

The examination will require students to answer three essay questions in one three-hour examination. Students will be required to select two questions from Part I of the course (the general theory course) and one from Part II (the specialized module). A sample examination paper is available on the Faculty website.

Pol 4. The analysis of modern politics III: Comparative politics

Assessment will be by means of a single 5,000-word essay and a two-hour written examination, each carrying 50% of the total mark. The examination paper will be divided into five sections: (A) Western Europe; (B) Eastern Europe; (C) the Middle East; (D) the US Presidential Election, 2008; and (E) state-formation in the Congo. There will be three questions in each of Sections A, B, and C, and two questions in Sections D and E, making a total of 13 questions. Candidates will be required to answer two questions, taking each from a different section, of which at least one must be from Sections A, B, or C. A sample examination paper is available on the Faculty website.

#### Pol 7. A subject in politics and international studies II: Politics of security and development

The examination will consist of a three-hour written paper. Candidates will be required to answer three questions from a choice of at least twelve, including questions on conflict and questions on peacebuilding. There will be at least one question on the Democratic Republic of the Congo, one on Iraq, and one on Cambodia. The paper will be undivided. A sample examination paper is available on the Faculty website.

Pol 8. A subject in politics and international studies III: The politics of Europe

The examination will be divided into three sections: (A) Anglo-American and British politics; (B) the politics of European integration; (C) comparative politics of Western Europe. Each section will consist of four to six questions. Candidates will be required to answer three questions, taken from at least two of the sections. A sample examination paper is available on the Faculty website.

Pol 9. A subject in politics and international studies IV: The politics of Africa

This paper examines questions about the politics of Africa. The examination will consist of twelve questions, of which candidates will be required to answer three. A sample examination paper is available on the Faculty website.

Pol 11. A subject in politics and international studies V: The politics of East Asia

The examination will consist of a three-hour written paper. Candidates will be required to answer three questions from a choice of sixteen questions, of which eight will pertain to the politics of China, and eight to the politics of Southeast Asia. The paper will be undivided. A sample examination paper is available on the Faculty website.

Pol 12. A subject in politics and international studies VI: The politics of the international economy

The content of the paper has been revised such that the topics in arguments in political economy have been replaced with topics on the euro-zone debt crisis. A sample examination paper is available on the Faculty website.

#### Sociology

Soc 4. A subject in sociology I: Media, culture, and society

The section on 'New media and society' (eight lectures) and the related examination questions on the paper set in 2011 will be replaced by a section entitled: 'Popular music in its social context' (twelve lectures). The examination will remain undivided and will contain questions relating to the new popular music section as well as questions relating to the sections on 'Theories of culture and the media' and 'Media and politics'.

All other papers remain unchanged.
