The Council gives notice that, after consultation with the General Board, and on the recommendation of the Nominating Committee for the appointment and reappointment of Pro-Vice-Chancellors (comprising the Vice-Chancellor as Chairman; Professor Frank Kelly, Dr David Good, Professor Shirley Pearce (members of the Council); and Professor Martin Danton and Professor Robert Kennicutt (members of the General Board)), it has appointed Professor Graham Virgo, *DOW*, as Pro-Vice-Chancellor (Education) for three years from 1 October 2014 and has reappointed Professor Jeremy Sanders, *SE*, as Pro-Vice-Chancellor (Institutional Affairs) for one year from 1 October 2014.

Appointment of a member of the Board of Scrutiny in class (c)(i)

16 December 2013

Regulation 2 for the election of members of the Board of Scrutiny (*Statutes and Ordinances*, p. 113) provides that, if at an election insufficient nominations are received to fill all the places either in class (c)(i) or in class (c)(ii), the Council shall appoint as many members as may be necessary.

No person having been nominated in the election for one member of the Board of Scrutiny in class (c)(i) (a person who has been a member of the Regent House for not more than ten years on 1 October 2013) in November 2013, the Council has appointed Dr Samantha Lucy, *N*, to the Board for four years from 1 October 2013.

Election of a member of the Council's Finance Committee in class (b)

A vacancy will arise for a member of the Regent House, elected by the Representatives of the Colleges, to serve on the Council's Finance Committee for three years from 1 January 2014. No nominations having been received by 18 December 2013 (*Reporter*, 6326, 2013–14, p. 102), nominations have been reopened.

The election is conducted in accordance with the Single Transferable Vote regulations. Voting is by postal ballot.

Nominations should be made in writing to the Head of the Registry's Office, University Offices, The Old Schools, Cambridge, CB2 1TN, and must include a statement by the person nominated that he or she is willing to serve on the Finance Committee. Nominations and statements should be made by 12 noon on Friday, 3 January 2014. Nominations should be supported by the signatures of two members of the Regent House. If a ballot is necessary, papers will be despatched by Thursday, 9 January, for return by 12 noon on Friday, 17 January 2014.

University Composition Fees

16 December 2013

In the following Notice the Council proposes amendments to the fees for certain categories of students as set out in the Table of Fees attached to the regulations for University Composition Fees.

Home and EU Undergraduate and certain other fees in 2014–15

Ordinances provide that recommendations for the University Composition Fees to be charged to Home and EU undergraduate students be accompanied by an analysis of the cost of an undergraduate education agreed by the General Board and the Council following consultation with the Colleges (*Statutes and Ordinances*, p. 156; Grace 13 of 26 May 2011). The outcome of the agreed calculation for 2011–12 is an average cost per student of £15.1k (showing a slight increase over the 2010–11 calculation of £14.8k; *Reporter*, 6291, 2012–13, p. 283) as follows:

Home and EU undergraduate students subject to the regulated maximum fee

The government has announced the rates for both new and continuing Home/EU undergraduate students. The 2014–15 maximum regulated fees for Old Regime and New Regime Home/EU undergraduates remain at the same values as in 2013–14. These fees are set out in Table 1 of the attached Schedule.

The last entries of Old System students were those few who deferred entry to 2006–07. None are expected to be continuing in 2014–15 and no Old System fee is necessary.

ELQ students

The regulated fee continues to apply to all students on ELQ exempt courses (Architecture, P.G.C.E., Medicine, and Veterinary Medicine).

The Council recommends that the fees for continuing Home/EU ELQ students on all other courses who commenced a course before 2012 be increased by 3.3%. The fees are shown in Table 5A in the attached Schedule.

The fee for Home/EU ELQ students admitted in and after 2012 is at the same level as the new regime regulated fee and will continue at that rate in 2014–15. It had been assumed the regulated fee would increase annually and it was never the intention that the ELQ fee should be fixed. The Council gives notice that the ELQ fee will be increased to £9,300 in 2015–16 for both new and continuing non-exempt ELQ students.

Continuing Island students

Continuing Island students admitted before 2012 are charged fees which are subject to an annual increase. The Council recommends that fees are increased by 3.3% with adjustments to ensure that fees do not exceed the rates paid by students admitted after 2012. The fees are set out in Table 5B in the attached Schedule.

Continuing Island students admitted in 2012 are charged fees which correspond to New Regime rates and for 2014–15 the fees will be unchanged from 2013–14.

Island students admitted in and after 2013 are charged fees at Overseas rates.

P.G.C.E. students

Fees for Home/EU P.G.C.E. students are regulated and therefore unchanged for 2014–15.

Home and EU undergraduate students taking a year abroad

For Old Regime students taking a year abroad in 2014–15 the fees remain at 50% of the otherwise applicable Home/EU fee rate (with a fee exemption for students taking a full year abroad under the Erasmus scheme).

For New Regime students taking a year abroad in and after 2014–15, the government has announced new maximum regulated fees as follows:

- (i) For New Regime students taking a study or work year abroad under the Erasmus scheme, or a study (not a sandwich (or work) placement) year abroad outside the Erasmus scheme, the maximum fee to be charged is 15% of the Home/EU fee (£1,350 for 2014–15).
- (ii) For New Regime students taking a sandwich year out outside the Erasmus scheme (whether in or outside the UK), the maximum fee to be charged is 20% of the Home/EU fee (£1,800 for 2014–15).

The Council proposes that a single year abroad fee is charged to all New Regime students at 15% (£1,350 in 2014–15), whether they are studying or working abroad, but whether the higher rate should be introduced for non-Erasmus students working abroad will be kept under review.

These rates also apply to any Home/EU students on ELQ exempt courses.

Other undergraduate students taking a year abroad

The Council proposes that the year abroad fee for all other students including Overseas, non-exempt ELQ, and continuing Island students continue to be 50% of the otherwise applicable fee.

Executive M.B.A.

The opportunity is being taken to publish a correction to the presentation of the fees for the 2013 intake for the Executive M.B.A., which are now shown as a single fee for the whole course instead of annual fees (students pay a registration fee followed by one or two instalments).

The Council is accordingly submitting a Grace to the Regent House (Grace 2, p. 247) for the approval of the fees set out in the Schedule attached to this Notice.

Asian and Middle Eastern Studies Tripos

SUPPLEMENTARY REGULATIONS

(Statutes and Ordinances, p. 283)

With immediate effect

The Supplementary Regulations have been amended for the Part II paper MES.38, available for examination under Regulation 8, by amending the current title and replacing the text so as to read:

MES.38 History of the modern Middle East: language, national identity, and conflict

The paper investigates the role language plays in articulating national identity and conflict in the Middle East. The main focus of the paper will be on Arabic, but consideration will also be given to Hebrew, Persian, and Turkish.

Land Economy Tripos

(Statutes and Ordinances, p. 356)

With effect from 1 October 2014

The General Board have, on the recommendation of the Faculty Board of Land Economy, approved the following amendments.

The title, content, and form of examination for Paper 3 have been amended so that legal research skills are now studied alongside the existing quantitative skills, and so that a project report is no longer required.

Regulation 12.

GROUP I

By retitling Paper 3 as ‘Quantitative and legal methods for land economists’.

By removing Paper 3 from the list of papers requiring the submission of a report.

SUPPLEMENTARY REGULATIONS

(Statutes and Ordinances, p. 359)

By replacing the detail of Paper 3 so as to read:

GROUP I

Paper 3. Quantitative and legal methods for land economy

An introduction to relevant skills required for successful study on the Land Economy Tripos. These include legal skills, mathematics (including refreshing mathematical skills), statistics, and qualitative policy analysis.

GROUPS I, II, AND III

Papers 3, 4, and 6: project reports

By amending the heading so as to read:

Papers 4 and 6: project reports

Law Tripos: Correction

(Statutes and Ordinances, p. 361)

With effect from 1 October 2014

The following amendment, which has been approved by the General Board on the recommendation of the Faculty Board of Law, is a correction to the Notice published on 27 November 2013 (*Reporter*, 6327, 2013–14, p. 117).

Regulation 18.

By placing the current regulation in square brackets, and by inserting a regulation in angular brackets so as to read:

<18. A candidate for honours in Part IB shall offer five papers chosen from among Papers 1, 2, and 4 and Groups II and III, provided that

- (i) a candidate who has not offered successfully Paper 5 in Part IA shall also offer Paper 5 in Part IB;
- (ii) a candidate who was not a candidate for honours in Part IA shall also offer Paper 5 in Part IB;
- (iii) a candidate shall not offer any paper which he or she has previously offered in another University examination.>

And by inserting two footnotes to the current regulation so as to read:

The regulation in angular brackets will replace the Regulation in square brackets with effect from 1 October 2014. Regulation 18(i) is applicable with effect from 1 October 2015.

Natural Sciences Tripos, Part IB

(*Statutes and Ordinances*, p. 399)

With effect from 1 October 2013

The General Board, on the recommendation of the Committee of Management for the Natural Sciences Tripos, have approved the following amendment.

Regulation 23.

The duration of the practical examination in Plant and Microbial Sciences is extended from one hour to one and a half hours.

FORM AND CONDUCT OF EXAMINATIONS, 2014

Notices by Faculty Boards, or other bodies concerned, of changes to the form and conduct of certain examinations to be held in 2014, by comparison with those examinations in 2013, are published below. Complete details of the form and conduct of all examinations are available from the Faculties or Departments concerned.

Human, Social, and Political Sciences Tripos, Part I, 2014: Correction

The Faculty of Human, Social, and Political Sciences give notice of a revision to the Form and Conduct Notice for the Human, Social, and Political Sciences Tripos (*Reporter*, 6327, 2013–14, p. 126). The Notice contained an error in the listing of set texts for 'Paper POL1: Analysis of politics', in section I: Fukuyama, *The origins of political order*, will not be a set text for 2013–14. This set text will instead be Fukuyama, *The end of history and the last man*, as shown in the paper guide. The Faculty are satisfied that no student's preparation for the examination will be disadvantaged by this change.

Natural Sciences Tripos, 2014

The Committee of Management for the Natural Sciences Tripos give notice that, with effect from the examinations to be held in 2014, the form and conduct of certain of the examinations for the Natural Sciences Tripos will be changed as follows:

PART IB

Physiology

The first written paper will carry 25% of the total marks and will last two hours. This paper will cover material which may be taken from any area of the lecture course and will consist of two sections. Section A will be mostly theory questions with all questions worth one mark each. Section B will be mostly data-handling questions with all questions worth three marks each. The questions in this paper will require candidates to choose the best answer from several alternatives. Candidates should answer all questions. The second written paper will last three hours and have five or more essay questions of which candidates should answer four. This paper will carry 60% of the total mark. The practical examination will last one hour and twenty minutes and carry 15% of the total marks. This paper will encompass material from both the experimental and histology practicals, and will be taken in the Department of Physiology, Development, and Neuroscience. The questions will require candidates to choose the best answer from several alternatives. Candidates should answer all questions.

Plant and Microbial Sciences

The practical component (25% of the total subject mark) will be changed as follows:

10% of the total subject mark will be awarded for practical write-ups (rather than 15%); 15% of the total subject mark will be awarded for the written practical examination (rather than 10%).

The practical write-ups component will consist of 5% for a formal report on the thematic Rubisco practical, and 5% for lab-book style reports on the weekly practicals (a minimum of five must be submitted; if more are submitted, the best five marks will be taken for assessment).

The written practical examination will be extended to 1.5 hours (from 1 hour) to include a longer structured question on data handling/experimental design. A specimen paper will be available later in the year.

PART II

Biological and Biomedical Science (BBS), Minor Subject in Conservation Science

The examination will consist of one three-hour written paper. The paper will consist of six questions with the rubric:

Answer **three** questions.

Start answering each question on a new sheet of paper. Write on one side of the paper only.

Please tie up the answer to **each** question separately with its own coversheet.

A sample paper will be available on the Zoology : NSTII 13_14 section of CamTools.

Biological and Biomedical Sciences (BBS), Neuroscience

Candidates taking BBS Neuroscience will sit the papers set for Part II Neuroscience (NST2NU) and not those set for Part II Physiology, Development, and Neuroscience (NST2PDN).

Physics

The title of the examination subject previously known as 'Experimental and Theoretical Physics' is amended to 'Physics'.

Physiology and Psychology

For the two psychology papers, candidates shall offer two of Papers 2, 3, and 4 from the subject Psychology Option (A).

Psychology

If a candidate offers four papers and a dissertation, the Examiners shall assess her or his performance on:

(i) Paper 1 and (ii) three of the following: Papers 2, 3, 4, or the dissertation, discounting the one component out of the four in which they judge the candidate's work to be least good, providing that no component out of Papers 2, 3, or 4 shall be discounted if it is not of at least second class standard.

PART III

Biochemistry

Paper 2 will be divided into two Sections. Section I will draw on the overall scope of the Workshops on Methods in Biochemistry and will require the critical evaluation of a short biochemical research article in response to a series of compulsory questions embedded in the text. Section II will contain three questions drawing on the overall scope of the Workshops on Landmark Papers in Biochemistry. Candidates shall answer one question from this section. Each section carries equal marks.

The duration of Paper 2 remains unchanged. All other papers remain unchanged.

Materials Science (Part III and Master of Advanced Study, M.A.St.)

The Techniques courses formerly examined in section A of Paper 1 are discontinued.

Section A of Paper 1 of the written examination will now contain questions based on the short (six-lecture) modules, there being one question from each such module. The rubric will read 'Answer any 3 questions from section A'.

Physics

The title of the examination subject previously known as 'Experimental and theoretical physics' is amended to 'Physics'.

Systems Biology

Paper 3, 'Modelling and analysis of networks', shall consist of a three-hour computer-based examination in which candidates will answer all questions. A specimen paper will be made available to all candidates before the end of the Lent Term. All other parts of the examination remain unchanged.

REPORTS**Second-stage Report of the Council on the construction of the Maxwell Centre on the West Cambridge site**

The COUNCIL begs leave to report to the University as follows:

1. In this Report the Council is seeking approval to proceed with the construction of the Maxwell Centre.

2. A First-stage Report to the University on the construction of the Maxwell Centre, dated 6 May 2013, was approved by Grace 1 of 5 June 2013 (*Reporter*, 2012–13; 6306, p. 507; 6311, p. 617).

3. As stated in the First-stage Report, the site for the proposed Maxwell Centre is located to the north end of the existing Physics of Medicine (PoM) building, adjacent to the William Gates Computer Sciences building. The proposed building will be approximately 4,900m² of laboratory, office, collaboration, and ancillary space. Also proposed is a 400m² refurbishment of the north end of the PoM building, converting temporary facilities into usable laboratory space. It is proposed to connect the PoM building and the Maxwell Centre via an internal link at both ground- and first-floor levels.

4. The construction of the Maxwell Centre will provide a centrepiece for industrial partnership with the physical sciences. The scale of industrial involvement is already substantial, but the target is to double this through a combination of activities in the new building, in the

collaborating departments, and in the commercial space on the West Cambridge site.

5. A Full Case for the building, under the Capital Projects process was approved by the Planning and Resources Committee on 3 July 2013. The current cost estimate for the project is £25.6m. A grant for £21m has been received from the HEFCE UK Research Partnership Infrastructure Fund 2013–15, with the balance contributed from the Capital Fund.

6. A planning application was submitted to the Cambridge City Council in June 2013 and approval was granted through a Reserved Matters application on 25 September 2013. The project should be largely complete by the end of March 2015, as the project is subject to a spending profile determined by HEFCE, although the project may extend by a few months.

7. A contractor, SDC, has now been appointed to work with the design team on the pre-construction process and has been asked to tender for the construction works.

8. Drawings of the proposed scheme are displayed for the information of the University in the Schools Arcade.

9. The Council recommends:

- I. That approval is confirmed for the construction of the Maxwell Centre as proposed in this Report.
- II. That the Pro-Vice-Chancellor (Planning and Resources) be authorized to accept a tender for the works, within the available funding, in due course.

The Council submits the following Graces to the Regent House. These Graces, unless they are withdrawn or a ballot is requested in accordance with the regulations for Graces of the Regent House (*Statutes and Ordinances*, p. 103), will be deemed to have been approved at 4 p.m. on Friday, 27 December 2013.

1. That Professor Dame Sandra Dawson, of Sidney Sussex College, be reappointed one of the Septemviri to serve for two years from 1 January 2014.
2. That the Table of Fees attached to the regulations for University Composition Fees (*Statutes and Ordinances*, p. 156) be amended for undergraduate and related fees for 2014–15, as set out in the Council's Notice, dated 16 December 2013 (p. 239).
3. That the regulations for the Joint Committee on Development (*Statutes and Ordinances*, p. 139) be rescinded and replaced by the regulations set out below.¹

JOINT COMMITTEE ON DEVELOPMENT

1. The Joint Committee on Development shall be a joint Committee of the Council and the Colleges and shall consist of:

- (a) the Vice-Chancellor and the Chair of the Colleges Committee (*ex officio*) who shall be co-Chairs;
- (b) a member of the Council appointed by the Council;
- (c) three members of the Regent House appointed by the Council, on the nomination of the General Board, who shall normally be persons having experience of fund-raising at the University level, one of whom shall be a Head of School;
- (d) a Head of House appointed by the Colleges' Standing Committee;
- (e) four persons appointed by the Colleges' Standing Committee having regard to their experience of fund-raising for the Colleges;
- (f) the Executive Director of Development and Alumni Relations;
- (g) the Executive Director of Cambridge in America.

Members in classes (b) to (e) shall be appointed in the Michaelmas Term to serve for three years from 1 January next following their appointment. The Pro-Vice-Chancellor (Planning and Resources), the Registrar, the Academic Secretary, the Director of the Finance Division, and the Chief Operating Officer of Development and Alumni Relations of the University Offices shall have the right to attend meetings of the Committee.

2. The Registrar shall designate a University officer to act as Secretary to the Joint Committee.

3. The duties of the Joint Committee shall be:

- (a) to monitor the performance of, and recommend revisions to, the overall strategy for fund-raising on behalf of the University and the Colleges;
- (b) to keep under review and facilitate the relationships and links between the University and the Colleges and their members;

- (c) to receive and approve nominations to the Guild of Benefactors;
- (d) to facilitate and support effective collaboration between the University and the Colleges;
- (e) to establish, implement, and ensure the effectiveness of codes of practice and policies in support of its remit;
- (f) to receive and review the budget and work plan for collaborative activity in fund-raising undertaken through the office of Cambridge in America in the USA, and any such similar bodies that may be established in future on a jointly funded basis elsewhere in the world, and to recommend them to the Planning and Resources Committee for approval.
