**Notice of benefactions**

*7 November 2016*

The Vice-Chancellor gives notice that he has accepted with gratitude the following benefactions, of which both the capital and the income may be used:

- (i) a benefaction of £3m from The Monument Trust to support projects to improve the Fitzwilliam Museum;
- (ii) philanthropic grants of £700,000 from the National Heritage Memorial Fund and of £200,000 from the Art Fund towards the purchase of the Castle Howard Cabinets, to be added to the Fitzwilliam Museum's collection;
- (iii) philanthropic grants amounting to £570,476 from the Evelyn Trust to support research projects in the School of Clinical Medicine (role of brain inflammation in early Parkinson's dementia, £207,985; personalized prostate risk prediction, £42,376; mitochondria and immune signalling, £33,333; mechanisms of kidney preservation by warm perfusion, £100,000; role of pressure slope in preterm baby ventilation, £26,800; early identification of perinatal ischaemic stroke, £98,502) and in the School of the Biological Sciences (cellular energetics and human disease, £61,480);
- (iv) benefactions of US\$500,000 from Arcadia and of £250,000 from The Rothschild Foundation, the latter payable over five years, to support the Cambridge Conservation Initiative's Collaborative Fund for Conservation, which provides grants for projects undertaken by CCI partners that address high priority biodiversity conservation issues;
- (v) a benefaction of £250,000 from the Frances and Augustus Newman Foundation, payable over two years, to support the refurbishment and operation of the Microfabrication Laboratory in the Department of Chemistry, to be named the Sir Rodney Sweetnam Laboratory for Micro- and Nanoscale Biomedical Science;
- (vi) a benefaction of a further £214,070 from Ms Claire Barnes to support two additional studentships in the Department of Zoology, to be named the Claire Barnes 150th Anniversary Studentship in the Biology and Ecology of Asia, and the Claire Barnes 150th Anniversary Studentship in Marine Biology (*Reporter*, 6419, 2015–16, p. 420);

- (vii) a benefaction of US\$200,000 from Cambridge in America, following a donation from the Tony and Elizabeth Tanke Donor Advised Fund at the InFaith Community Foundation, to support the Centre for English Legal History in the Faculty of Law;
- (viii) a benefaction of CA\$100,000 from the Horne Family Charitable Foundation to support research into multiple sclerosis undertaken by the research group of Professor Alasdair Coles in the Department of Clinical Neurosciences.

The Vice-Chancellor also gives notice that he has accepted with gratitude a benefaction of £1.5m from the Hatton Trust to support a Hatton Lectureship in the Philosophy of Public Health in the Department of History and Philosophy of Science. The Council is publishing a Grace for the approval of the regulations to govern the fund (Grace 1, p. 101).

## **A strategic framework for the development of the University estate**

*7 November 2016*

The Council and the General Board wish to report to the Regent House that they have approved a strategic framework for the development of the University estate, which has been published here: <http://www.em.admin.cam.ac.uk/strategic-framework>.<sup>1</sup> The framework has been prepared by the University's Estates Strategy Committee, which was established (by Grace 5 of 21 May 2014) as a sub-committee of the Planning and Resources Committee (PRC). The Committee is chaired by the Pro-Vice-Chancellor (Planning and Resources) and includes representatives from the Council and from among the Heads of Schools, as well as the Chairs of the Buildings Committee and the West and North West Cambridge Estates Board (formerly the West and North West Cambridge Estates Syndicate). The work of the Estates Strategy Committee has been informed by direction received since 2014 from both the Council and the General Board, and specifically by contributions from Heads of Schools and Pro-Vice-Chancellors at a workshop convened for that purpose in November 2015. The Pro-Vice-Chancellor (Enterprise and Regional Affairs) has led a limited set of external meetings with the local planning authorities.

A University estate strategy was previously requested and approved by PRC in 2012 in order to provide strategic context for the emerging Capital Plan. That document focussed narrowly on the physical estate at an operational level, and within relatively short-term horizons. The document prepared by the Estates Strategy Committee seeks to ensure that the University estate supports the University's mission by developing and managing the estate so that it will:

- be an expression of the University's academic excellence, with high quality places and services, in order to contribute to the University's and the City's competitive advantage;
- support productivity by delivering a positive experience for students and staff;
- be developed sustainably;
- deliver value for money, and generate additional income, to improve the University's financial position.

A number of estate-specific goals are identified for these four performance areas, and strategies are articulated to achieve each goal. Some of these are novel within the University; others draw on examples of current good practice and seek to apply them more widely and systematically. Rather than specifying targets and actions to be applied uniformly across the University, the intention is to establish a framework for future decision-making and articulate proposals for further work that will inform plans for improvement. To this end, presentations will be scheduled with Councils of the Schools and other University bodies concerned with academic, financial, and infrastructure planning. Some of this work is expected to generate outputs that will require scrutiny and formal approval by University committees and, where appropriate, the Regent House. The framework will be reviewed after an initial period of two years.

## Teaching and Learning Innovation Fund, 2016–17

The Digital Teaching and Learning Sub-committee is pleased to announce that the Teaching and Learning Innovation Fund is now accepting bids for 2016–17, for the purpose of implementing innovative practice in any area of learning and teaching provision. The Fund has been developed specifically to provide start-up funding for creative or exploratory projects ineligible for other sources of funding; bids should focus on new approaches or initiatives that enhance learning and teaching. The Sub-committee expects to be able to support up to ten projects in 2016–17.

Any innovative project will be considered and need not necessarily be IT-focused; however, bids in support of technology to enhance teaching and learning are particularly welcome. Requests for funding primarily or solely for the purchase of equipment will not be accepted.

Note that normally grants will be between £10,000–£20,000 but exceptionally requests for smaller grants will be considered. The Fund is only available for internal members of the University of Cambridge, and external bids will not be considered.

Successful applicants will report back to the Sub-committee within a year of funds being allocated, including evaluation of the project's success. Projects should therefore be realistic and take these time constraints into account when submitting a bid. Successful applicants will be asked to contribute to activities sponsored by the Cambridge Centre for Teaching and Learning.

**REPORTS****Report of the General Board on the establishment and re-establishment of certain Professorships**

The GENERAL BOARD begs leave to report to the University as follows:

1. The General Board recommends the establishment and re-establishment of certain Professorships as set out in paragraphs 2, 3, 4, 5, and 6 below. The funding arrangements for the Bennett Professorship of Public Policy, the Dr John C. Taylor Professorship of Innovation, the Professorship of Oncological Imaging, the Professorship of Cell Biology, and the Professorship of Clinical Microbiology were scrutinized by the Resource Management Committee at its meeting on 12 October 2016.

2. The Board has accepted an academic case from the Council of the School of the Humanities and Social Sciences for the establishment of a Bennett Professorship of Public Policy, from 1 October 2017, in the Department

of Politics and International Studies. If recommendations I and II of this Report are approved, the Professorship will be funded by a benefaction of £2.5m from Mr Peter Bennett to be held on trust by the University as an endowment fund and governed by the regulations in Annex I to this Report; the endowment will also support a Fellowship at Churchill College to be held by the post-holder of the Bennett Professorship. The Board has agreed that election to the Professorship should be made by an *ad hoc* Board of Electors and that the candidature should be open to all persons whose work falls within the general field of the title of the office

3. The Board has accepted an academic case from the Council of the School of Technology for the establishment of a Dr John C. Taylor Professorship of Innovation, from 1 October 2017, in the Department of Engineering. If recommendations III and IV of this Report are approved, the Professorship will be funded by a benefaction of £2.5m from Dr John C. Taylor OBE to be held on trust by the University as an endowment fund and governed by the regulations in Annex II to this Report. The Board has agreed that election to the Professorship should be made by an *ad hoc* Board of Electors and that the candidature should be open to all persons whose work falls within the general field of the title of the office.

4. The Board has accepted an academic case from the Council of the School of Clinical Medicine for the establishment of a Professorship of Oncological Imaging, from 1 August 2017, for a single tenure in the Department of Radiology. Fifty per cent of the costs of the Professorship will be met by the Cambridge University Hospitals NHS Foundation Trust; for the first five years the Cambridge Cancer Centre will contribute £50,000 per annum and any shortfall will be met from Cambridge Biomedical Research Centre funding. Thereafter the School of Clinical Medicine will underwrite the other 50% of the salary costs of the Professorship from within its recurrent Chest allocation. The Board has agreed that election to the Professorship should be made by an *ad hoc* Board of Electors and preference should be given to those candidates whose work falls within the field of oncological imaging with expertise in MRI, CT, and PET multimodal function imaging techniques.

5. The Board has accepted an academic case from the Council of the School of Clinical Medicine for the establishment of a Professorship of Cell Biology, from 1 March 2017, for a single tenure in the Department of Clinical Biochemistry. The full cost of the Professorship will be met through existing resources available to the School of Clinical Medicine. The Board has agreed that election to the Professorship should be made by an *ad hoc* Board of Electors and preference should be given to those candidates whose work falls within the field of the cell biology of disease.

6. The Board has accepted an academic case from the Council of the School of Clinical Medicine for the establishment of a Professorship of Clinical Microbiology, from 1 October 2016, for a single tenure in the Department of Medicine. The costs of the Professorship will be shared as follows: 50% by Public Health England, 25% by Cambridge University Hospitals NHS Foundation Trust, and 25% by the School of Clinical Medicine from within its recurrent Chest allocation. The funding from Public Health England will be renewed on a five-year basis subject to the performance of the post-holder. Cambridge University Hospitals NHS Foundation Trust will also offer an honorary consultant position to the appropriate appointee. The Board has agreed that election to the Professorship should be made by an *ad hoc* Board of Electors and that the candidature should be open to all persons whose work falls within the general field of the title of the office.

7. The General Board recommends:

- I. That a Bennett Professorship of Public Policy be established in the University from 1 October 2017, placed in the Schedule to Special Ordinance C (vii) 1, and assigned to the Department of Politics and International Studies.
- II. That regulations for a Bennett Fund for Public Policy, as set out in Annex I to this Report, be approved.
- III. That a Dr John C. Taylor Professorship of Public Innovation be established in the University from 1 October 2017, placed in the Schedule to Special Ordinance C (vii) 1, and assigned to the Department of Engineering.
- IV. That regulations for a Dr John C. Taylor Professorship of Innovation Fund, as set out in Annex II to this Report, be approved.
- V. That a Professorship of Oncological Imaging be established in the University from 1 August 2017 for a single tenure, placed in the Schedule to Special Ordinance C (vii) 1, and assigned to the Department of Radiology.
- VI. That a Professorship of Cell Biology be established in the University from 1 March 2017 for a single tenure, placed in the Schedule to Special Ordinance C (vii) 1, and assigned to the Department of Clinical Biochemistry.
- VII. That a Professorship of Clinical Microbiology be established in the University from 1 October 2016 for a single tenure, placed in the Schedule to Special Ordinance C (vii) 1, and assigned to the Department of Medicine.

**Annex I**

## BENNETT FUND FOR PUBLIC POLICY

1. The benefaction received from Peter W. Bennett, together with such other sums as may be received or applied for the same purpose, shall form an endowment fund called the Bennett Fund for Public Policy to advance research in the field of public policy by supporting a Bennett Professorship of Public Policy.

2. The Managers shall be responsible for the administration of the Fund and the application of its income and shall comprise the Head of the School of the Humanities and Social Sciences, who shall be Chair, the Chair of the Faculty of Human, Social, and Political Science, and the Head of the Department of Politics and International Studies.

3. Subject to Regulation 4, the income of the Fund shall be applied towards the following:

- (a) the payment of the stipend, national insurance, pension contributions, and associated indirect costs of the Bennett Professorship of Public Policy payable by the University;
- (b) a distribution of 6 per cent of the annual income of the Fund to Churchill College in each financial year in support of a linked Fellowship for the holder of the Professorship, provided that the distribution shall not be paid in any year during the whole of which the Fellowship is vacant and shall be reduced *pro rata* in respect of any year in which the Fellowship is held for part only of that year.

4. Any unexpended income in any financial year, including income accrued during a vacancy in the Professorship or the linked Fellowship, may, at the discretion of the Managers:

- (a) with the approval of the Faculty Board of Human, Social, and Political Science, be applied to support the work of the Professor in such manner as may be recommended by the Managers;
- (b) with the approval of the General Board, be applied to support research in the field of public policy in the University in such manner as may be recommended by the Managers; and/or
- (c) be carried forward for use as income in accordance with Regulation 3 in any one or more subsequent financial years.

**Annex II**

## DR JOHN C. TAYLOR PROFESSORSHIP OF INNOVATION FUND

1. The funds received from Dr John C. Taylor OBE, together with such other sums as may be received or applied for the same purpose, shall form an endowment fund called the Dr John C. Taylor Professorship of Innovation Fund to advance research in the field of engineering innovation, and education by supporting a Dr John C. Taylor Professorship of Innovation.

2. The Managers shall be responsible for the administration of the Fund and the application of its income and shall comprise the Head of the School of Technology, the Head of the Department of Engineering, and the Head of the Division of Manufacturing and Management within the Department of Engineering, one of whom shall be Chair.

3. Subject to Regulation 4, the income of the Fund shall be applied towards the payment of the stipend, national insurance, pension contributions, and associated indirect costs of the Dr John C. Taylor Professorship of Innovation payable by the University.

4. Any unexpended income in any financial year, including income accrued during a vacancy in the Professorship, may, at the discretion of the Managers:

- (a) with the approval of the Faculty Board of Engineering, be applied to support the work of the Professor in such manner as may be recommended by the Managers;
- (b) with the approval of the General Board, be applied to support research in the field of engineering in the University in such manner as may be recommended by the Managers; and/or
- (c) be carried forward for use as income in accordance with Regulation 3 in any one or more subsequent financial years.

**GRACES****Grace submitted to the Regent House on 9 November 2016**

The Council submits the following Grace to the Regent House. This Grace, unless it is withdrawn or a ballot is requested in accordance with the regulations for Graces of the Regent House (*Statutes and Ordinances*, p. 103), will be deemed to have been approved at 4 p.m. on Friday, 18 November 2016.

1. That a Hatton Philosophy of Public Health Fund be established in the University, to be governed by the following regulations:<sup>1</sup>

**HATTON PHILOSOPHY OF PUBLIC HEALTH FUND**

1. The sums received by the University from the Hatton Trust to support teaching and research in the Department of History and Philosophy of Science, along with other donations received for the same purpose, shall form a fund called the Hatton Philosophy of Public Health Fund.

2. The first charge on the income of the Fund shall be the stipend, national insurance, pension contributions, and associated indirect costs payable by the University in respect of a Lectureship in the Department of History and Philosophy of Science to be known as the Hatton Lectureship in the Philosophy of Public Health.

3. The Fund shall be administered by the Managers of the Hatton Philosophy of Life Sciences Fund.

4. After provision has been made in accordance with Regulation 2, the income of the Fund may be applied for the support of teaching or research in the philosophy of public health as shall be approved by the General Board on the recommendation of the Managers.

5. Any unexpended income in a financial year shall either be added to the capital of the Fund or accumulated for use as income in any one or more subsequent years, as the Managers may determine.
