**Notice of benefactions**

The Vice-Chancellor gives notice that he has accepted with gratitude the offer of a benefaction of US\$2m from the Andrew Mellon Foundation as endowment funding, to be matched two-to-one over five years, to support interdisciplinary programmes organized and administered by the Centre for Research in the Arts, Social Sciences, and Humanities, and the first payment of match funding of £1m from the Isaac Newton Trust, also payable over five years. The Council is publishing a Grace for the approval of the regulations to govern an Interdisciplinary Research in the Arts, Social Sciences, and Humanities Fund, which will receive both these initial funds of £1.5m and any funds received in the future for the same purpose (Grace 5, p. 377).

## **Second Joint Report of the Council and the General Board on the consideration of student complaints of harassment and sexual misconduct: Notice in response to Discussion remarks**

20 February 2017

The Council and the General Board have considered the remarks made at the Discussion on 7 February 2017 (*Reporter*, 6455, 2016–17, p. 368) concerning the above Report (*Reporter*, 6452, 2016–17, p. 326).

Mr Shah expresses concern at the possibility that the University might persist with disciplinary proceedings even when the police have declined to prosecute. The University Advocate already has the power to charge a member of the University in such circumstances, see Regulation 4 of the Ordinance on initiation of proceedings (and also Statute D II 16); it is not a power which the Second Joint Report seeks to introduce.

Mr Shah also expresses concern about a respondent's right to receive evidence in connection with disciplinary proceedings against him or her. The recommendations in the Second Joint Report are not concerned with the procedural rules for the disclosure of evidence to respondents in disciplinary proceedings. Paragraph 6.2.3(a), to which Mr Shah refers, is a provision in the Procedure for Handling Cases of Student Harassment and Sexual Misconduct, which, as paragraph 6 of the First Report (*Reporter*, 6445, 2016–17, p. 132) makes clear, is not intended to be disciplinary or to involve any finding of wrongdoing. Mr Shah's concerns will be referred for consideration under the current review of student disciplinary procedures.

Mr Shah also makes comments on the draft Special Ordinance concerning precautionary measures. He argues that there must be substantial grounds before precautionary measures are imposed, that an evidential standard should be specified, that the person on whom measures are imposed should be informed as to the basis for the decision, and that the Academic Secretary should be directed to consider the impact of the measures on the person on whom they are imposed. He also argues that the draft Special Ordinance does not address the incidental consequences of imposing precautionary measures, for example in relation to the payment of fees.

Precautionary measures are not disciplinary in nature; as Section 4 of the Special Ordinance indicates, their imposition does not constitute any penalty or sanction or (as Mr Shah notes) imply any finding of wrongdoing. Nevertheless, the discretion to impose measures cannot be exercised lightly and the Academic Secretary must at all times act in good faith and fairly and impose measures only where he or she considers them to be necessary for the purposes set out in Section 1 of the Special Ordinance. The measures are equivalent to an administrative suspension pending investigation or similar process; accordingly there is no need for a formal evidential standard, which would be applicable only if formal findings of fact were required to be made by the Academic Secretary (which they are not). Under Sections 4 and 5 of the Special Ordinance, before deciding whether or not to impose (or re-impose) any precautionary measures on any person, the Academic Secretary must give that person a reasonable opportunity to submit written representations or, in cases where it is not possible or appropriate to do so due to the urgent or sensitive nature of the matter, a person on whom measures have been imposed is entitled to request a review by submitting written representations to the Academic Secretary. Such representations may include submissions about the impact of any measure on the person in question. In addition, any person on whom measures are imposed must be notified in writing of the grounds for imposing them. As regards incidental consequences, the draft Special Ordinance provides that the Academic Secretary may, at the request of a student on whom precautionary measures are imposed, allow a term of residence, put the student in standing for the purposes of examination, or agree such other academic arrangement as he or she may think fit. The remission of fees will be handled in the usual way by the Applications Committee or the Board of Graduate Studies, as appropriate.

The Council is submitting a Grace (Grace 3, p. 377) for the approval of the recommendations of this Report.

**REGULATIONS FOR EXAMINATIONS****Computer Science Tripos, Part II**

(*Statutes and Ordinances*, p. 291)

**With immediate effect**

The General Board, on the recommendation of the Faculty Board of Computer Science and Technology, has approved an amendment to the regulations for this degree so as to permit the electronic submission of Part II dissertations, as follows:

Regulation 17.

By amending the second sentence of the regulation to read:

The dissertation, which shall not exceed 12,000 words in length, excluding appendices, footnotes, and bibliography, shall be submitted by the candidate to the Head of the Department in a format as prescribed by him or her so as to arrive not later than noon on the third Friday before the first day of the examination.

The Board is satisfied that no candidate's preparation for the examination in 2017 will be affected by this change.

### Asian and Middle Eastern Studies Tripos, Part IB, 2017

(*Statutes and Ordinances*, p. 268)

Further to its Notice of 16 November 2016 (*Reporter*, 6444, 2016–17, p. 108) the Faculty Board of Asian and Middle Eastern Studies gives notice that, with effect from the examinations to be held in 2017, the form of examination for the following paper of Part IB of the Asian and Middle Eastern Studies Tripos will be as specified below:

*Middle Eastern Studies / Middle Eastern Studies with a Modern Language*

*MES.16 Hebrew literature (special topics)*

This paper will be divided into two sections. Section A will contain four questions on Modern Hebrew culture and Section B will contain four questions on Medieval Hebrew texts. Candidates will pick one section from which they must answer all four questions. All questions carry equal marks.

The Faculty Board of Asian and Middle Eastern Studies is satisfied that no candidate's preparation for the examination will be affected.

## REPORTS

### Report of the General Board on the establishment of a Professorship of Cancer Sciences

The GENERAL BOARD begs leave to report to the University as follows:

1. The General Board recommends the establishment of a Professorship of Cancer Sciences as set out in paragraph 2 below. The funding arrangements were approved by the Resource Management Committee on 8 February 2017.

2. The General Board has accepted an academic case from the Council of the School of Clinical Medicine for the establishment for a single tenure of a Professorship of Cancer Sciences, from 1 February 2018, in the Department of Oncology. The full cost of the Professorship will be met

by Cancer Research UK. The Professor of Cancer Sciences will be appointed as Director of the Cancer Research UK Cambridge Institute in accordance with the agreement between the University and Cancer Research UK concerning the governance of the Institute. The General Board has agreed that election to the Professorship should be made by an *ad hoc* Board of Electors and that candidature should be open without limitation or preference to all persons whose work falls within the general field of the title of the Professorship.

3. The General Board recommends:

I. That a Professorship of Cancer Sciences be established for a single tenure in the University, from 1 February 2018, placed in the Schedule to Special Ordinance C (vii) 1 and assigned to the Department of Oncology.

1. That PricewaterhouseCoopers LLP be reappointed, in accordance with Statute F I 5, to be the qualified accountants for the audit of the University's financial statements for the financial year 2016–17.<sup>1</sup>
2. That the Annual Report of the Council for the academical year 2015–16 (*Reporter*, 6448, 2016–17, p. 202) be approved.<sup>2</sup>
3. That the recommendations in paragraph 6 of the Second Joint Report of the Council and the General Board, dated 23 January 2017 and 18 January 2017, on the consideration of student complaints of harassment and sexual misconduct (*Reporter*, 6452, 2016–17, p. 326) be approved.<sup>3</sup>
4. That the Table of Fees attached to the regulations for University Composition Fees (*Statutes and Ordinances*, p. 150) be amended for 2018–19 as set out in the Schedule to the Council's Notice dated 20 February 2017 (p. 371).<sup>4</sup>
5. That an Interdisciplinary Research in the Arts, Social Sciences, and Humanities Fund be established in the University, to be governed by the following regulations:<sup>5</sup>

INTERDISCIPLINARY RESEARCH IN THE ARTS, SOCIAL SCIENCES, AND HUMANITIES FUND

1. Benefactions and such other sums as may be received or applied for the same purpose shall form a fund called the Interdisciplinary Research in the Arts, Social Sciences, and Humanities Fund to support the Centre for Research in the Arts, Social Sciences, and Humanities (CRASSH).

2. The Fund shall be administered by Managers who shall comprise the Head of the School of Arts and Humanities and the Head of the School of the Humanities and Social Sciences (one of whom shall be Chair), and the Director of CRASSH, any of whom may appoint a deputy to serve as Manager on her or his behalf.

3. Subject to Regulation 4, the income of the Fund shall be applied to support CRASSH (or a successor body) in such manner as the Managers shall decide, including but not limited to the payment of the stipend, national insurance, pension contributions, and associated indirect costs of any office or post payable by the University, and the funding of research, conferences, and other events.

4. Any unexpended income in any financial year may, at the discretion of the Managers, be carried forward for use as income in accordance with Regulation 3 in any one or more subsequent financial years.
