The Vice-Chancellor gives notice that the Discussion announced for Tuesday, 30 April 2019 has been cancelled as there are no Reports ready for discussion. The next Discussion is scheduled to take place on 14 May 2019.

**Grace for submission to the Regent House under Special Ordinance A (i) 5 (report on the advantages and disadvantages of a policy of divestment)**

22 March 2019

The Council has received the following Grace, which has been initiated under Special Ordinance A (i) 5 by 324 members of the Regent House.

Grace 1 of 11 January 2017 called for the University to divest its Endowment from *companies whose business is wholly or substantially concerned with the extraction of fossil fuels*. The Regent House **notes** that in its response to the Grace, the Council announced its intention to commission a report *specifically into the advantages and disadvantages of the policy of divestment which the Grace supports*.

The Regent House has not received such a report because the terms of reference of the Divestment Working Group (DWG) did not refer to advantages or disadvantages of divestment but asked for a broader consideration of the issues. The Council's response, published on the 20 June 2018 similarly did not weigh the advantages and disadvantages but rather stated the Council's opposition to a policy of divestment, and passed on to other matters.

The Regent House therefore **directs** the Council to produce a report to the University that will

1. set out fully the advantages and disadvantages, including the social and political ones, of a policy of divestment from fossil fuels,
2. assess the moral acceptability of a University committed to educating future generations, and whose core values include sustainability, benefitting from investments in fossil fuels that threaten that future,
3. provide costed estimates of the effects, positive and negative, on the performance of the University's investments of such a policy,
4. provide a full assessment of the reputational effects, positive and negative, of a policy of divestment,
5. provide, as requested by the Grace of 11 January 2017, costed details of possible strategies for how the University might divest from fossil fuels.

Such a report should be compiled with appropriate Regent House and student input. It should be completed within 6 months, or failing that an interim report with a detailed timeline to completion should be produced.

A list of the signatories is set out in Annex A.

The Council will consider the Grace at a forthcoming meeting.<sup>1</sup>

## USS Update: University's response on the approaches and assumptions to be adopted for the 2018 USS valuation

The University's response to USS's statutory consultation on the assumptions and approaches to be adopted for the 2018 valuation of USS has been published and is available at <https://www.admin.cam.ac.uk/reporter/2018-19/weekly/6543/cambridge-response-uss-2018-valuation.pdf>

The University submitted its views, which are broadly in line with those of other university employers, to UUK, which has responded to the USS Trustee on behalf of all USS employers. The Trustee is expected to respond in early May.

In its response, the University supported UUK's proposals for an overall contribution rate of 29.2 per cent, with 9.1 per cent to be paid by members and 20.1 per cent by employers. This is slightly higher than the overall rate of 28.3 per cent that applies from 1 April 2019 under the first phase of cost-sharing, but significantly lower than the rates that would apply if the second and third phases of cost-sharing were implemented. The University noted that the contingent contribution mechanism, and the valuation approach more generally, should be reviewed at the earliest opportunity following the second phase of the Joint Expert Panel's review of USS and its valuation methodology. In appendices to its response, the University set out its own analysis of USS's approach to the consultation and outlined some alternative approaches to measuring scheme self-sufficiency.

**REGULATIONS FOR EXAMINATIONS****Human, Social and Political Sciences Tripos**

(*Statutes and Ordinances*, p. 356)

**With effect from 1 October 2019**

The General Board, on the recommendation of the Faculty Board of Human, Social and Political Science, has approved amendments to the regulations so as to remove references to assessment methods which will be done instead by Form and Conduct notices, ensure that students have a balanced assessment and take papers with examination and dissertation elements, specify which Head of Department can approve single track and joint track dissertations, introduce optional papers from the Archaeology Tripos to replace some Biological Anthropology papers and to widen student choice, change paper titles to provide a more accurate description of the papers and replace a no longer available Faculty of Education paper with an available one.

Regulation 11, Section A.

By amending the title of Paper SOC1 *from* 'Modern Societies I: introduction to sociology' *to* 'Introduction to sociology: Modern societies I'.

Regulation 15.

By amending the titles of certain papers, retaining where applicable the shared paper references, to read as follows:

POL5.	Themes and issues in politics and international relations (also serves as an optional paper for Part IB of the History and Politics Tripos)
POL19.	Themes and issues in politics and international relations II
POL20.	A subject in politics and international relations VIII
POL21.	A subject in politics and international relations IX
SOC14.	A subject in sociology IX

And, under Social Anthropology,

- (i) by inserting a footnote to the sub-heading ‘Special subjects in social anthropology’ so as to read ‘Three or four of these papers will be available each year, as announced by the Department by the end of Easter Term in the previous academic year’; and
- (ii) by removing the footnote from the following individual papers: SAN7, SAN8, SAN9, SAN10 and SAN14.

Regulation 16.

By amending Regulation 16 so as to read:

**16.** Each paper shall be assessed either by a three-hour examination or by a combination of two or more of the following: a coursework portfolio; an essay of not more than 5,000 words; a two-hour examination. The mode of examination for each paper, and details of any coursework or essays required, and about the arrangements for their submission, shall be published by the Faculty Board not later than the beginning of the Michaelmas Term.

Regulation 17.

By amending Regulation 17(c)(iv) so as to read:

- (iv) one paper chosen from the following list: Papers A1, A3, B1–B4<sup>1</sup> and A11 from the Archaeology Tripos, POL5–6, SAN7–14, SOC2–3, Paper 10 or Paper 11 from Part I of the Historical Tripos, Paper 1 or Paper 2 for the subject History and Philosophy of Science in Part IB of the Natural Sciences Tripos, Papers PBS3–4 of the Psychological and Behavioural Sciences Tripos.

By amending Regulation 17(e)(iv) so as to read:

- (iv) one paper chosen from the following list: Papers A1, A3, B1–B4<sup>1</sup> and A11 from the Archaeology Tripos, POL3–4, SAN7–14, SOC4–5, Paper 10 or Paper 11 from Part I of the Historical Tripos, Paper 1 or Paper 2 for the subject History and Philosophy of Science in Part IB of the Natural Sciences Tripos, Papers PBS3–4 of the Psychological and Behavioural Sciences Tripos, Paper ED3 in Part IB of the Education Tripos.

Regulation 18.

By replacing at the end of the second sentence, the text ‘papers and other exercises as follows’ with ‘four papers, of which at least three shall be assessed by written examination, either in part or in whole.’

And by amending Regulation 18(c) so as to read:

(c) *Candidates in Politics and International Relations*

- (i) POL9;
- (ii) two papers chosen from POL10–21; one paper may be substituted by a dissertation on a subject approved by the Head of the Department of Politics and International Studies, which shall be submitted in accordance with the provisions of Regulation 19;
- (iii) one paper chosen from the following: A14–18 and B2–B4<sup>1</sup> from Part II of the Archaeology Tripos, SAN7–14<sup>2</sup>, SOC6–15<sup>3</sup>, Paper 5 or Paper 6 for the subject History and Philosophy of Science in Part II of the Natural Sciences Tripos, Paper 6 from Part II of the Historical Tripos, Paper 8 borrowed from Part II of the Economics Tripos, or a further paper chosen from POL6<sup>4</sup> and POL10–21<sup>5</sup>.

- (i) one paper chosen from SOC5–13<sup>1, 2</sup>;
- (ii) two further papers chosen from SOC5–15<sup>1, 2</sup>, one of which may be substituted by a dissertation on a subject approved by the Head of the Department of Sociology, which shall be submitted in accordance with the provisions of Regulation 19;
- (iii) one paper chosen from the following list: A14–18, A61 and B2–B4<sup>3</sup> from Part II of the Archaeology Tripos, POL13<sup>4</sup>, POL17<sup>4</sup>, SAN7–14<sup>5</sup>, Papers PBS6–9 of the Psychological and Behavioural Sciences Tripos, a further paper chosen from SOC5–15.

- (iv) a candidate may substitute for one paper a dissertation on a subject within the field of Sociology or Criminology approved by the Head of the relevant Department, which shall be submitted in accordance with the provisions of Regulation 19.

And by amending Regulation 18(l)(iii) so as to read:

- (iii) a candidate may substitute for one paper a dissertation on a subject within the field of Sociology or Social Anthropology approved by the Head of the relevant Department, which shall be submitted in accordance with the provisions of Regulation 19.

And by replacing the last sentence of Regulation 19(a) with the following text:

Applications shall be submitted to the Head of the relevant Department in which the dissertation will be examined so as to arrive not later than the division of the Full Michaelmas Term next preceding the examination.
