Strategic review of email provision in the University: Implementation of findings

Following the strategic review of email provision in the University (*Reporter*, 6546, 2018–19, p. 528) and the announcement of the amended timetable (*Reporter*, 6552, 2018–19, p. 696), the final review report was discussed at the Information Services Committee (ISC) at its meeting on 5 March 2019. The ISC recommended the formation of an email service provision technical scrutiny panel, chaired by Dr Jessica Gardner, which met on 1 July 2020. The ISC approved the panel's recommendation that new individual and shared mailboxes should be provisioned on Exchange Online and not Hermes, and agreed that UIS should present a plan for the decommissioning of Hermes.

The ISC agreed a target deadline of 31 December 2021 for the conclusion of the work of the scrutiny panel and its oversight of the decommissioning of Hermes.

Engineering Tripos, 2020–21

(*Statutes and Ordinances*, November 2020, p. 327)

With immediate effect

The Faculty Board of Engineering gives notice of a change to the Supplementary Regulations for Part IB of the Engineering Tripos as follows:

SUPPLEMENTARY REGULATIONS

Paper 8. Selected Topics.

By replacing the final sentence of the text for Paper 8. Selected topics, with the following:

In addition there will be a section on The Engineer in Business, from which candidates will be required to complete multiple choice questions.

The Faculty Board is satisfied that no candidate's preparation for the degree will be affected by the change.

Examinations, 2020–21

The Faculty Board of Engineering also gives notice that, with effect from the examinations to be held in 2021, the form of the examinations for certain papers of the Engineering Tripos will be changed as follows:

PART IB

Paper 8. Selected topics

The section on The Engineer in Business will now be multiple choice in which candidates must answer all questions. All other details of the examination remain unchanged.

PART IIA

3D8. Environmental Geotechnics

This paper was previously known as 'Building Physics and Environmental Geotechnics'. All other details of the examination remain unchanged.

3G1. Molecular Bioengineering I

This paper was previously known as 'Introduction to Molecular Bioengineering'. All other details of the examination remain unchanged.

PART IIB

4F2. Robust and Nonlinear Control

This paper was previously known as 'Robust and Nonlinear Systems and Control'. This module has changed from examination to 100% coursework.

4G5. Materials and Molecules: Modelling, Simulation and Machine Learning

This new module will be examined through 100% coursework.

4M23. Electricity and Environment

This was previously 'Paper 4I7, Electricity and Environment'. All other details of the examination remain unchanged.

Natural Sciences Tripos, Part Ib (Neurobiology), 2020–21

The Faculty Board of Biology gives notice, with effect from the examinations to be held in Easter Term 2021, that the form of examination for the two written papers for Neurobiology in Part Ib of the Natural Sciences Tripos will be as follows:

Both papers will require knowledge of cellular, molecular, developmental, sensory, motor and cognitive neurobiology, in the broad areas covered by the lecture course.

Paper 1 will be a three-hour paper requiring four essay answers from a choice of ten questions.

Paper 2 will be a one-and-a-half-hour paper divided into two sections, A and B. NST Candidates are required to answer all questions. PBS candidates are only required to answer questions from section A.

Section A will examine material in the broad areas covered by the lecture course and will require candidates to either give short answers, or to choose the best answer from several alternatives, or to plot, draw, mark or annotate graphs or diagrams.

Section B will examine the material from the practical classes. It will require candidates to either give short answers, or to choose the best answer from several alternatives, or to plot, draw, mark or annotate graphs or diagrams.

Natural Sciences Tripos, Part II (Psychology, Neuroscience and Behaviour), 2020–21

The Faculty Board of Biology gives notice, with effect from the examinations to be held in Easter Term 2021, that the form of examination for the Research Project for Psychology, Neuroscience and Behaviour in Part II of the Natural Sciences Tripos will be as follows:

Research Project

The examination shall consist of a grant proposal of not more than 4,000 words, excluding abstract (500 words), footnotes, figure legends, tables, bibliography and appendices, to be submitted by the first Friday of Full Lent Term; and a research dissertation of not more than 4,000 words, excluding abstract (500 words), footnotes, figure legends, tables, bibliography and appendices, to be submitted by the fifth day of Full Easter Term. The weighting of each submission shall be as follows: 50% grant proposal, 50% research dissertation.

Natural Sciences Tripos, Part II (Biological and Biomedical Sciences), 2021–22

The Faculty Board of Biology gives notice, in accordance with Regulation 30 for the Natural Sciences Tripos, that the following combinations of Major and Minor Subjects will be available for Biological and Biomedical Sciences in Part II of the Natural Sciences Tripos in 2021–22.

Subject to any restrictions announced in a particular year by the Faculty Board under the provisions of Regulation 30, candidates for the examination in Biological and Biomedical Sciences for Part II of the Natural Sciences Tripos are required to offer:

- (a) The examination requirements of one Major Subject;
- (b) The examination requirements of one Minor Subject;
- (c) A dissertation of not more than 6,000 words, excluding tables, figures, and references.

All subjects make provision for candidates to offer a dissertation.

Each subject's available and permissible combinations are listed below. Some subjects have restrictions on the number of candidates that can be accepted. Where possible this is indicated below – further information will be available as part of the Part II Subject Allocation process.
