**NOTICES BY THE GENERAL BOARD****Examinations and assessment, 2021**

13 May 2021

In September 2020, the General Board noted that, as part of the University's Covid-19 contingency planning, its Education Committee was working with Departments and Faculties, and in consultation with the Senior Tutors' Committee, to ensure that assessment could take place in 2020–21 should in-person examinations not be possible (*Reporter*, 6589, 2020–21, p. 9). Those plans were updated in Lent Term 2021, following the government's decision to implement a further period of lockdown from January 2021 and the increasing unlikelihood of all students being able to return to Cambridge before 17 May 2021. The Council agreed on 15 April 2021 to waive residence requirements during Easter Term 2021 (*Reporter*, 6613, 2020–21, p. 469).

The Board is satisfied that there has been sufficient consultation and that the exceptional circumstances created by the Covid-19 pandemic justify the use of the authority granted by Graces 20–25 of 29 July 2020. It therefore gives notice that it has agreed to make the following changes to the standard arrangements for examinations in 2021:

- (a) The dates and the process concerning the form and conduct of any examination or part of an examination have been revised, and the normal three-hour duration of written papers waived.

Definitive information on the form and conduct of examinations in Easter Term 2021 is available on the websites of the Departments, Faculties and other institutions responsible for the course. This will, in some cases, supersede the information about the form and conduct of those examinations published in the *Reporter* earlier in this academic year.

- (b) No class-lists will be published for any examinations in 2020–21.

Colleges, Departments and Faculties will as usual receive the examination results for their students, but to a revised timetable (see below).

- (c) The requirement for Examiners to attend examinations and provide a scheme concerning the attendance at examinations has been waived.

This is a blanket waiver, given that most examinations will not be in-person examinations.

The Board is currently consulting on the dates of examinations in the Easter Term 2021 and the dates by which those examination results will be available for release to students and to their Departments, Faculties and Colleges. This information will be published on the Student Registry website once finalised (<https://www.cambridgestudents.cam.ac.uk/your-course/examinations/all-students-timetable>). However, it is already clear that in many cases these dates will not fall within the examination timetable as set out in Ordinance. The Council, on the recommendation of the Board, is therefore seeking approval to set aside the relevant regulation for the duration of the examination season in Easter Term 2021 (Grace 1, p. 664) and, to the extent that it is already too late to do so by Grace, to exercise the authority granted to it by Regulation 4 of the Ordinance on Dates of Examinations and Publication of Class-lists (*Statutes and Ordinances*, p. 248).

The Board has separately provided information on the framework for assessment in 2021–22 (p. 661).

## Examinations and assessment, 2021–22: Framework for assessment

13 May 2021

The General Board has agreed a Framework for Assessment for Undergraduate and Postgraduate Taught Programmes in 2021–22 (available at: <https://www.admin.cam.ac.uk/reporter/2020-21/weekly/6618/AssessmentFramework2022.pdf>). This draws on the lessons learned as a result of the University's response to the Covid-19 pandemic, and responds to the desire of many Faculties and Departments to move away from the traditional three-hour written examination format as the primary means of assessment for such programmes. The framework anticipates that the 2021–22 academic year will be a transition year, enabling a mixed model of assessment to continue, to give time for preparatory steps to be taken, including the review of current General Board Regulations governing the scheme of examination for relevant degree courses.

In support of those aims, the Council has agreed to seek approval for the extension of the authority granted to the General Board by Grace in July 2020 to waive certain requirements in Ordinance by Notice (Graces 2–8, p. 664; see *Reporter*, 6587, 2019–20, p. 543).

### REGULATIONS FOR EXAMINATIONS

#### Master of Business Administration

(*Statutes and Ordinances*, p. 449)

##### With effect from 1 October 2022

The General Board, on the recommendation of the Faculty Board of Business and Management, has approved an addition to the regulations for the degree of Master of Business Administration, to introduce a new pathway, the Global Executive Master of Business Administration course. Amendments will also be made to Options A and B to ensure consistency.

Regulation 12.

By replacing 'give notice of' with 'publish' throughout Options A and B.

By inserting new Option C, to read as follows, and adding a reference to the option in the first line of the regulation:

*Option C: Global Executive M.B.A. course*

A course extending over a period of two years comprising a number of course units and project work, which shall include not less than 300 hours of formal University instruction and not less than 120 hours of open study prescribed by the Faculty Board. The examination for Option C shall consist of compulsory modules, elective modules, and project work, as outlined below. Examination of the modules may be by written paper, essay, coursework, or another mode of assessment announced by the Faculty Board. Each candidate will have to complete a minimum of three written papers, the duration of which will be published by the Faculty Board.

(a) *Compulsory modules*

The Faculty Board shall publish the topics and form of assessment for each compulsory module by the end of the Easter Term immediately preceding the start of the course.

(b) *Elective modules*

The Faculty Board shall publish the topics and form of assessment for elective modules by the end of the term immediately preceding the term in which the work is to be completed.

(c) *Project work*

The Faculty Board shall publish the format and length for submission of project work by the end of the Lent Term, provided that the Board shall have the power of subsequently issuing amendments if they have due reason for doing so and they are satisfied that no student's preparation for the examination will be adversely affected.

The Examiners shall have power to examine a candidate *viva voce* on any or all of the three sections of the examination (a)–(c).

No student's name shall appear on the list of successful candidates for the M.B.A. Examination unless the Director of the Judge Business School is satisfied that the student has diligently attended the course.

#### History for the M.St. Degree

(*Statutes and Ordinances*, p. 564)

##### With effect from 1 October 2021

The General Board, on the recommendation of the Strategic Committee of the Institute of Continuing Education, has approved an annual intake for the examination in History for the degree of Master of Studies with effect from 1 October 2021. The footnote noting biennial admission to the course has therefore been removed.

## CULP Awards in French, German, Italian, Portuguese, Advanced Russian and Spanish

(*Statutes and Ordinances*, p. 601)

### With effect from 1 October 2020

The General Board, on the recommendation of the Committee of Management of the Language Centre, has approved the amendment of the regulations for this award so as to change the date of the final examination.

Regulation 2.

By amending the second sentence to read as follows:

The final examination shall take place at the end of the course and will be of two hours' duration.

## REPORTS

### Report of the General Board on the establishment of certain Professorships

The GENERAL BOARD begs leave to report to the University as follows:

1. The General Board recommends the establishment of a Professorship of Penal Theory and Ethics and an MRC Professorship of Statistics, as set out in paragraphs 2 and 3 below, and approved under the Recruitment Protocol, in effect until 31 July 2021.

2. The Board has accepted an academic case from the Council of the School of the Humanities and Social Sciences and the Institute of Criminology, for the establishment in perpetuity of a Professorship of Penal Theory and Ethics from 1 January 2022, in the Institute of Criminology. The salary costs of the Professorship will be supported by a donation of £2.5m to the University from Emeritus Honorary Professor Andreas von Hirsch, to be held on trust by the University as an endowment fund to be called the Andreas von Hirsch Fund for Penal Theory and Ethics. The Council for the School of the Humanities and Social Sciences has agreed to underwrite the costs in the event of any shortfall in funding. The Faculty Board has agreed that election to the Professorship will be made by an *ad hoc* Board of Electors and that the candidature should be open to all persons whose work falls within the general field of the title of the office.

3. The Board has accepted an academic case from the Faculty Board of Clinical Medicine and the Council of the

School of Clinical Medicine for the establishment for a single tenure, from 1 July 2021, of an MRC Professorship of Statistics in the Department of Public Health and Primary Care. The holder of the Professorship will be Dr Thomas Jaki, Programme Leader in the Design and Analysis of Randomised Trials (DART) in the MRC Biostatistics Unit, and Professor in Statistics at the University of Lancaster (he will remain in the latter role for 10% of his time on taking up the Professorship at Cambridge). The full salary costs of the Professorship will be funded by the Medical Research Council. The Professorship will be dependent on Dr Jaki continuing to be the Programme Leader of DART. The appointment of Dr Jaki to the Professorship will provide leadership for this research theme and will fulfil part of the MRC's recommendations following a quinquennial site visit in December 2017.

The Board is mindful that it has not yet responded to Mr Allen's comments on its policy concerning the establishment of Professorships for named individuals (*Reporter*, 6614, 2020–21, p. 534). It wishes to confirm that the proposal in this case has been the subject of robust review, which included a formal interview of Dr Jaki by a panel chaired by the Head of the School of Clinical Medicine following the receipt of three references.

#### 4. The General Board recommends:

I. That a Professorship of Penal Theory and Ethics be established from 1 January 2022, placed in the Schedule to Special Ordinance C (vii) 1, and assigned to the Institute of Criminology.

II. That an MRC Professorship of Statistics be established from 1 July 2021 for the tenure of Dr Thomas Jaki, placed in the Schedule to Special Ordinance C (vii) 1, and assigned to the Department of Public Health and Primary Care.

III. If Recommendation I is approved, that regulations for an Andreas von Hirsch Fund for Penal Theory and Ethics, as set out in the Annex to this Report, be approved.

## ANNEX

## ANDREAS VON HIRSCH FUND FOR PENAL THEORY AND ETHICS

1. The benefaction received from Professor Andreas von Hirsch, together with such other sums as may be received or applied for the same purpose, shall form an endowment fund called the Andreas von Hirsch Fund for Penal Theory and Ethics to advance research in the field of criminology by supporting an Andreas von Hirsch Professorship of Penal Theory and Ethics.

2. The Managers shall be responsible for the administration of the Fund and the application of its income and shall comprise the Chair of the Management Committee of the Institute of Criminology, the Director of the Institute of Criminology and the Wolfson Professor of Criminology or, if the Wolfson Professor of Criminology is the Director of the Institute, a person co-opted by the other Managers from among the members of the Institute for such period as the other Managers shall determine.

3. Subject to Regulation 4, the income of the Fund shall be applied towards the payment of the stipend, national insurance, pension contributions, and associated indirect costs of the Andreas von Hirsch Professorship of Penal Theory and Ethics payable by the University.

4. Any unexpended income in any financial year, including income accrued during a vacancy in the Professorship, may, at the discretion of the Managers, and with the approval of the Council of the School:

- (a) be applied to support the work of the Andreas von Hirsch Professor of Penal Theory and Ethics;
- (b) be applied to support research in the field of criminology in the University in such manner as may be recommended by the Managers; and/or
- (c) be carried forward for use as income in accordance with Regulation 3 in any one or more subsequent financial years.

**Graces to be submitted to the Regent House at a Congregation on 22 May 2021**

The Council has sanctioned the submission of the following Graces to the Regent House at a Congregation to be held on 22 May 2021:

1. The relevant regulations notwithstanding, that the title of the degree of Doctor of Science *honoris causa* be conferred in absence under Statute A II 14 upon Professor EDITH HEARD, B.A., F.R.S., Honorary Fellow of Emmanuel College, Professor of Epigenetics and Cellular Memory, Collège de France, and Director General of the European Molecular Biology Laboratory, epigeneticist and developmental biologist.<sup>1</sup>
2. The relevant regulations notwithstanding, that the title of the degree of Doctor of Science *honoris causa* be conferred in absence under Statute A II 14 upon Professor Sir ROGER PENROSE, O.M., Ph.D., F.R.S., Honorary Fellow of St John's College, Emeritus Rouse Ball Professor of Mathematics, University of Oxford, Nobel Laureate, mathematical physicist and philosopher of science.<sup>1</sup>

<sup>1</sup> As an exceptional measure, the Council is submitting Graces renewing authority for these degrees and setting aside the relevant regulations concerning conferral of titular degrees, to allow this to take place immediately and in absence on these individuals (first approved by the Regent House on 21 March 2020). It is acting with the support of both the Senate-House Syndicate and the Council's Honorary Degree Committee and with the consent of the recipients. This measure responds to the cancellation of two successive Honorary Degree Congregations and offers these individuals a similar opportunity to that available to those currently receiving complete degrees in absence; i.e. graduation with the opportunity to attend a Congregation later to have their degrees formally celebrated. The intention is for the recipients of these Honorary Doctorates to be presented to the Chancellor in Congregation by the Orator in due course and there is no intention to change the procedures for future conferrals.

The relevant regulations notwithstanding, that the title of the degree of Doctor of Science *honoris causa* be conferred in absence under Statute A II 14 upon Professor Sir JOHN ERNEST WALKER, F.R.S., F.Med.Sci., Fellow of Sidney Sussex College, Emeritus Honorary Professor of Molecular Bioenergetics and Emeritus Director of the MRC Mitochondrial Biology Unit, the School of Clinical Medicine, Nobel Laureate, biochemist and molecular biologist.<sup>1</sup>

5. The relevant regulations notwithstanding, that the title of the degree of Doctor of Letters *honoris causa* be conferred in absence under Statute A II 14 upon Professor HENRY LOUIS GATES JR, Ph.D., Honorary Fellow of Clare College, Alphonse Fletcher University Professor and Director of the Hutchins Center for African and African American Research, Harvard University, literary scholar, cultural critic, journalist and filmmaker.<sup>1</sup>

6. The relevant regulations notwithstanding, that the title of the degree of Doctor of Letters *honoris causa* be conferred in absence under Statute A II 14 upon Professor Sir SIMON MICHAEL SCHAMA, C.B.E., M.A., F.R.S.L., F.B.A., Honorary Fellow of Christ's College and sometime Leslie Stephen Lecturer, University Professor of Art History and History, Columbia University, historian and art historian.<sup>1</sup>

7. The relevant regulations notwithstanding, that the title of the degree of Doctor of Letters *honoris causa* be conferred in absence under Statute A II 14 upon ALISON MAY SMITH, C.B.E., F.R.S.L., Honorary Fellow of Newnham College, of Clare Hall and of Lucy Cavendish College, Senior Fellow Commoner in the Creative Arts of Trinity College, writer, playwright and academic.<sup>1</sup>

8. The relevant regulations notwithstanding, that the title of the degree of Doctor of Music *honoris causa* be conferred in absence under Statute A II 14 upon Ms JUDITH WEIR, C.B.E., M.A., Hon. F.R.S.E., Honorary Fellow of King's College and of Trinity College, sometime Visiting Fellow Commoner in the Creative Arts of Trinity College, Master of The Queen's Music and President of the Royal Society of Musicians, composer.<sup>1</sup>
