### Discussion on 22 March 2022: Cancellation

The Vice-Chancellor gives notice that the Discussion announced for Tuesday, 22 March 2022 will not take place as there are no items ready for Discussion. The next Discussion is scheduled to take place on 3 May 2022.

### Notice of a benefaction

3 March 2022

The Vice-Chancellor gives notice that he has received with gratitude a benefaction of £3,325,000 from Viking Expedition Ltd, payable over six years, to endow a Viking Professorship of Polar Marine Geoscience. The Council is submitting a Grace (Grace 1, p. 311) for the approval of regulations for a Viking Polar Marine Geoscience Fund. The Fund is being established in the first instance so that the initial payments from the donor can be invested in the University's Endowment Fund (CUEF). A proposal to establish the Professorship will be submitted to the Regent House for approval in advance of receipt of the final payments, with the aim of making an appointment once the Fund is able to support the Professorship.

### Joint Report of the Council and the General Board on changes to the recruitment process for clinically qualified academics to Professorships: Notice in response to Discussion remarks

8 March 2022

The Council has received the remarks made at the Discussion on 22 February 2022 on the above Report (*Reporter*, 2021–22: 6646, p. 256; 6649, p. 304). The Council has consulted with the General Board in providing this response.

Professor Evans raises a concern about the 'risk of debasement of the Professorial title', following recent changes to academic titles. The Council notes that the changes proposed by Grace 5 of 29 July 2020, which introduced new titles for academic offices below that of Professor, were intended to address dissatisfaction with the titles and gathered significant support in the ballot on that Grace (*Reporter*, 6601, 2020–21, p. 279). The Council's view is that this Report's proposals are unlikely to undermine the value of the title of Professor. After implementation of transitional arrangements, only those who are deemed to be of the calibre for appointment to a Professorship at Grade 12 will be appointed to a Clinical Professorship.

Professor Evans also queries whether the title of the Ordinance on Emeritus Officers indicates that the holders of emeritus titles hold offices. The Council can confirm that no office is conferred; the title of the Ordinance describes a group of officers who hold emeritus titles (just as Emeritus Professors do not hold the office of Professor).

Finally, Professor Evans asks whether the emeriti, in future to include the Clinical Professors, will be allowed to continue to use their '@cam.ac.uk' email addresses, noting the recent closure of a consultation on a revised policy governing the use of such email addresses (*Reporter*, 6646, 2021–22, p. 255). The Council has referred this comment for consideration by the Information Services Committee alongside other feedback received during the consultation.

The Council is submitting a Grace (Grace 2, p. 311) for the approval of the recommendations of this Report.

## REGULATIONS FOR EXAMINATIONS

### History and Modern Languages Tripos

(*Statutes and Ordinances*, 2021, p. 356)

The General Board, on the recommendation of the Faculty Board of Modern and Medieval Languages and Linguistics, has approved the following amendments to the regulations for the History and Modern Languages Tripos to correct certain errors and references in the regulations, to retitle certain papers, suspend certain papers in academic year 2021–22 and to make other amendments concerning the availability of papers.

#### With effect from 1 October 2021

Regulation 3.

By replacing references to ‘Senior Examiner’ with ‘Examiner’.

Regulation 6.

By removing the regulation and renumbering subsequent regulations.

Regulation 18.

By amending sub-paragraph (iv) by adding the following paper under Section C:

Paper 6. States between states: The history of international political thought from the Roman empire to the early nineteenth-century

By adding the following as the final sentence of the regulation:

The Faculty Board shall have discretion in exceptional circumstances to allow a candidate, on the application of their Tutor, to offer these papers in a language listed in Regulation 10 which they did not offer as a language paper in Part IA or Part IB.

Regulation 19.

By amending the first sentence of sub-paragraph (c) to read as follows:

A dissertation shall be not less than 10,000 words in length, inclusive of notes, but exclusive of the bibliography and any appendices, shall show knowledge of primary sources, and shall give full reference to all sources used.

The Faculty Board shall have discretion in exceptional circumstances to allow a candidate, on the application of their Tutor, to offer these papers in a language listed in Regulation 18(a) which they did not offer as a language paper in Part IA or Part IB;

**Systems Biology**

In order to be a candidate for honours in Systems Biology in Part III of the Natural Sciences Tripos, a student from the Natural Sciences Tripos should have obtained at least a II.1 in a single-subject in Part II of the Natural Sciences Tripos.

Participation by students from the Mathematical Tripos will be considered on a case-by-case basis and a II.1 in Part II is normally expected.

Professor SIR EDWARD ANTHONY WRIGLEY, M.A., Ph.D., FBA, Honorary Fellow and formerly Master of Corpus Christi College, Honorary Fellow and sometime Bursar of Peterhouse, Emeritus Professor of Economic History, co-founder of the Cambridge Group for the History of Population and Social Structure and formerly Chair of the Isaac Newton Trust, sometime President of the British Academy, the British Society for Population Studies and the Economic History Society, Founder's Medallist, the Royal Geographical Society, and Leverhulme Medallist, the British Academy, died on 24 February 2022, aged 90 years.

1. That a Viking Polar Marine Geoscience Fund be established in the University, to be governed by the following regulations:<sup>1</sup>

#### VIKING POLAR MARINE GEOSCIENCE FUND

1. The benefaction received from Viking Expedition Ltd, together with such other sums as may be received or applied for the same purpose, shall form an endowment fund called the Viking Polar Marine Geoscience Fund to advance research in the field of polar environmental science by supporting a Viking Professorship of Polar Marine Geoscience. The Professorship will normally be held in the Scott Polar Research Institute.

2. The Managers shall be responsible for the administration of the Fund and the application of its income and shall comprise the Head of the School of the Physical Sciences, the Head of the Department of Geography, and the Director of the Scott Polar Research Institute, one of whom shall be appointed Chair by the Board.

3. Subject to Regulation 4, the income of the Fund shall be applied towards the payment of the stipend, national insurance, pension contributions, and associated indirect costs of the Viking Professorship of Polar Marine Geoscience payable by the University.

4. Any unexpended income in any financial year, including income accrued during a vacancy in the Professorship, may, at the discretion of the Managers:

- (a) with the approval of the Faculty Board of Earth Sciences and Geography, be applied to support the work of the Professor in such manner as may be recommended by the Managers;
- (b) with the approval of the General Board, be applied to support research in the field of polar environmental science in the Scott Polar Research Institute in such manner as may be recommended by the Managers;
- (c) be carried forward for use as income in accordance with Regulation 3 in any one or more subsequent financial years, and/or
- (d) be applied to the capital of the Fund, for a period of up to 21 years from receipt of the donation<sup>[1]</sup> from Viking Expedition Ltd.

2. That the recommendations in paragraph 11 of the Joint Report of the Council and the General Board, dated 9 February 2022, on changes to the recruitment process for clinically qualified academics to Professorships (*Reporter*, 6646, 2021–22, p. 256) be approved.<sup>2</sup>

3. Regulation 1 of the Ordinance for the office of University Organist notwithstanding (*Statutes and Ordinances*, 2021, p. 713), that the Council may appoint to two offices of University Organist, any stipend for the single office established under Regulation 1 being divided equally between the two persons appointed for such time as both hold an office of University Organist.<sup>3</sup>
