University of Cambridge Financial Regulations

5 May 2022

The Council, on the advice of the Finance Committee and the University's internal auditors, has approved an amendment to the Financial Regulations. This amendment takes effect from 1 June 2022 and revises the Regulations published in the *Statutes and Ordinances* (p. 1064).

The purpose of the Financial Regulations is to ensure the proper use of finances and resources in a manner which not only satisfies the requirements of internal control expected of a substantial and prominent organisation, but also fulfils any legal or financial obligations as laid down by the Statutes and Ordinances of the University, HM Revenue and Customs, the Office for Students, and other authorities.

The last sentence of paragraph 31.3 concerning expenses has been revised to read as follows, to confirm that compliance with the Financial Procedure on expenses is mandatory:

Staff must follow the rules on expenses reimbursement as set out in the Financial Procedures Manual.

Related changes have also been made to the Financial Procedure on expenses.

REGULATIONS FOR EXAMINATIONS

Scientific Computing for the M.Phil. Degree

(Statutes and Ordinances, p. 555)

With effect from 1 October 2023

The General Board, on the recommendation of the Degree Committee for the Faculty of Physics and Chemistry, has approved amendments to the Special Regulations for the examination in Scientific Computing for the degree of Master of Philosophy to split the dissertation requirement into two separate reports.

Regulation 2(a).

By revising the text of Regulation 2(a) to read as follows:

(a) a dissertation consisting of two reports (each of not more than 7,500 words in length including tables, figure legends, and appendices, but excluding bibliography) on different sections of a major project involving in-depth original scientific research and a literature survey of the topic. The topic of the project and details of the requirements for each report shall be approved by the Degree Committee;

Master of Studies, General Regulations: Flexible learning

(Statutes and Ordinances, p. 567)

With effect from 1 October 2021

The General Board has approved amendments to the General Regulations for the degree of Master of Studies to formalise the adoption of flexible or progressive learning within recognised nested awards, as follows:

Regulation 4.

By inserting a new Regulation 4 to read as follows and renumbering the remaining regulations:

4. The General Board, on the recommendation of the Strategic Committee of the Institute, shall have powers to recognise periods of previous successful study in the University as meeting part of the requirements for the award.

Schedule to the General Regulations.

By amending the descriptive text of the Schedule to read as follows:

Courses approved for flexible periods of study under Regulation 4

REPORTS

Joint Report of the Council and the General Board on the appointment of Student Discipline Officers

The COUNCIL and the GENERAL BOARD beg leave to report to the University as follows:

- 1. This Report proposes changes to the arrangements for the appointment of Student Discipline Officers, to allow a larger number than two to be appointed and to establish a panel from which a Student Discipline Officer (SDO) can be allocated to consider an allegation. SDOs have decision-making powers in relation to student disciplinary matters, including whether to commission an investigation into an alleged breach of the Rules of Behaviour, and whether to impose a minor sanction or measure or refer the matter to the Discipline Committee.
- 2. Currently, there is provision for two members of the Regent House to be appointed, one as Student Discipline Officer and the other as Deputy Student Discipline Officer. The Deputy is called upon to act in circumstances where the Student Discipline Officer is unavailable or has a
- conflict of interest. The proposed changes remove the role of Deputy Student Discipline Officer and replace it with a panel of SDOs from which the SDO to consider a potential breach of the Rules of Behaviour is allocated by lot from among those on the panel who are available and have no conflict of interest. No change is proposed to the criteria for and method of appointment as SDOs, who will continue to be members of the Regent House appointed by Grace on the nomination of the General Board.
- 3. The Council and the General Board support the Report's recommendations because the changes will provide greater flexibility in allocating an SDO to a case, and will also make it possible to spread the load of cases among a wider group of SDOs. The recommendations have the support of the current Student Discipline Officer.

4. The Council and the General Board recommend:

- I. That Special Ordinance D (ii) 2(a) (Statutes and Ordinances, p. 102) be amended to read as follows:
- **2.** (a) The Student Discipline Officers shall be at least two members of the Regent House appointed by Grace on the nomination of the General Board with responsibility for commissioning an investigation into a potential breach of the Rules of Behaviour, deciding whether to refer the matter to another procedure, and determining whether a Registered Student's criminal convictions require the University to take further action. The Student Discipline Officers shall be appointed to a panel. A Student Discipline Officer shall be allocated to consider a potential breach of the Rules of Behaviour by lot drawn from among the Student Discipline Officers on the panel who are available and have no conflict of interest. The Academic Secretary or a duly appointed deputy may appoint another Student Discipline Officer from the panel to consider that potential breach if the allocated Student Discipline Officer subsequently becomes unable or unwilling to act.
- II. That, if Recommendation I is approved before the period of appointment of the current Student Discipline Officer expires on 30 September 2022, that Officer shall become a Student Discipline Officer on the panel.

END OF THE OFFICIAL PART OF THE 'REPORTER'

REPORT OF DISCUSSION

Tuesday, 3 May 2022

A Discussion was held by videoconference. Deputy Vice-Chancellor Professor Johan van de Ven was presiding, with the Registrary's deputy, the Senior Proctor, the Senior Pro-Proctor and three other persons present.

The following items were discussed:

Report of the General Board, dated 22 March 2022, on the re-establishment of a Professorship

(Reporter, 6652, 2021–22, p. 330).

No remarks were made on this Report.

Annual Reports and Financial Statements for the year ended 31 July 2021

(Reporter, 6653, 2021–22, p. 338).

No remarks were made on this Report.

Report of the Council, dated 21 April 2022, on changes to the operation of the Land Fund

(Reporter, 6654, 2021–22, p. 435).

Professor G. R. Evans (Emeritus Professor of Medieval Theology and Intellectual History), read by the Senior Pro-Proctor:

Deputy Vice-Chancellor, it has been drawn to the Council's attention that the implications of an Ordinance of 1974, have been overlooked. The Ordinance (*Statutes and Ordinances*, p. 125), still in force, sets the rules for what is to be done with the proceeds when the University sells land or leases it, unless the land is held solely as an investment. Otherwise, the money is to be held in a Land Fund, from which, apart from covering the costs of planning applications, payments may be made only 'to purchase sites which are suitable for development for University purposes'.

'University purposes' are recognised by the present *Statutes and Ordinances* only twice, both times for contrast with 'College purposes'. The Report uses the expression three times, apparently assuming that they are now of two kinds, 'operational' and 'non-operational'.

In 1974 'University purposes' were limited to the 'operational', what the Further and Higher Education Act 1992, s. 65(2)(*b*) was later to describe as:

the provision of any facilities, and the carrying on of any other activities, by higher education institutions in their area which the governing bodies of those institutions consider it necessary or desirable to provide or carry on for the purpose of or in connection with education or research.

This was a restriction sitting comfortably within the charitable status of the University.

Cambridge's classification of 'non-operational' purposes is much more recent, appearing first I think in a Report on 21 May 2015.² In the *Statutes and Ordinances* the 'non-operational' Estate is defined as comprising:

Land and buildings held for the general purposes of the University (e.g. residences) and land and property that could be needed in the foreseeable future for the Operational Estate. It is managed on a self-funded basis and remits income to the Chest.³

The 'operational' Estate is defined as:

Land and buildings currently used for teaching and research or for administrative and other support functions, including the University Farm, and retention of specialist use and 'churn' space but excluding land used by Cambridge University Press and Cambridge Assessment (the Local Examinations Syndicate).³

Land held for 'investment purposes' is not mentioned and 'churn' is not defined. 'Investment' is of course on the agenda for an exceptional extra Discussion next week.

The 'operational' University is now also being called 'the Academic University', an expression which seems first to have appeared in the Allocations Report in June 2020, explored further in a Council Notice in the *Reporter* of 22 October 2020 but remains undefined in *Statutes and Ordinances*.

Might it be timely and wise to tidy up the terminology and the definitions in the *Statutes and Ordinances*?
