16 February 2023

The Registrary has received notice from the Clerk of the Privy Council that His Majesty the King, at a Council held on 15 February 2023, was pleased to approve amendments to Statutes A IV 2(*b*), C and E I 7, which were submitted under the Common Seal of the University in accordance with Grace 2 of 9 March 2022.

The changes acknowledge in Statute the office of Clinical Professor, adding the holders of the office to those eligible for election to the Council in class (b) and inserting an enabling provision to ensure that Clinical Professors can be considered for appointment to Professorships supported by a trust fund.

Discussions

16 February 2023

The Council has agreed to update its guidance on Discussions and Fly-sheets (reproduced in *Statutes and Ordinances*, p. 116). A new paragraph 6 has been added to encourage contributors at Discussions to provide information on any interests they have in the subject matter on which they are making remarks, and the remaining paragraphs renumbered.

6. The Council considers it good practice for speakers at a Discussion to indicate any interest they have in the matter for discussion, normally after giving their name and any College and/or University institution affiliation at the beginning of their remarks. Where many speakers are likely to share the same interest (for example, where the item for discussion concerns pay or pensions or student-related matters), the Vice-Chancellor or other person presiding at the Discussion may note this interest on behalf of all speakers before inviting them to make their remarks.

17 February 2023

Ballot information and timetable

The vote will be conducted by ballot in accordance with the Single Transferable Vote Regulations. In connection with this ballot the Registrary will arrange for the circulation of any fly-sheet signed by ten or more members of the Regent House received by 1 p.m. on Friday, 3 March 2023; fly-sheets from other groups, as noted in the Council's Notice on Discussions and Fly-sheets, will also be accepted by the same deadline (*Statutes and Ordinances*, p. 116). This is also the deadline for amendments (*Statutes and Ordinances*, p. 112). Members of the Regent House are asked to use the Regent House Petitions site to circulate fly-sheets. Online voting will open at 10 a.m. on Wednesday, 15 March 2023 and close at 5 p.m. on Friday, 24 March 2023. Hardcopy voting papers and supporting materials will be distributed not later than Wednesday, 15 March 2023 to those who opted in November 2022 to vote on paper; the last date for the return of voting papers is 5 p.m. on Friday, 24 March 2023.

Review of the University Retirement Policy

20 February 2023

The Joint Report of the Council and the General Board on a retirement policy for University staff (*Reporter*, 6249, 2011–12, p. 347) stated that the continued application of a retirement age for University officers should be subject to review and its impact and other relevant factors be monitored. A review in 2015–16 concluded that the Employer Justified Retirement Age (EJRA) of 67 should be maintained. A further review planned for 2019–20 was delayed by the Covid-19 pandemic, but is now scheduled to take place in 2023.

The Council and the General Board have established a Retirement Policy and EJRA Review Group to conduct the review, which will consider:

- 1. the operation of the University's current Employer Justified Retirement Age, to determine whether it has been successful in meeting its aims; and
- 2. the terms of the University's current Retirement Policy, to establish whether they remain fit for purpose.

The Review Group will consult with the University community during the review, including in connection with any proposed recommendations to change the current arrangements.

Acting Vice-Chancellor: Extension of period of appointment

20 February 2023

In May 2022, the Council confirmed the appointment of Dr Anthony Freeling as Acting Vice-Chancellor for an initial appointment of six months from 1 October 2022. In that Notice, the Council noted that the term would be extended, up to a maximum of another six months, in the event that the Vice-Chancellor Elect was only able to take up office after 1 April 2023 (*Reporter*, 6659, 2021–22, p. 507). The Regent House has since approved the appointment of Professor Deborah Prentice as Vice-Chancellor from 1 July 2023 (*Reporter*, 2022–23; 6668, p. 3; 6677, p. 141). The Council gives notice that it has approved an extension to the period of appointment of the Acting Vice-Chancellor for three months, from 1 April until 30 June 2023 (no other changes to the terms of the appointment have been made). The Vice-Chancellor Elect will work alongside the Acting Vice-Chancellor from April 2023 in preparation for taking up the office of Vice-Chancellor on 1 July 2023.

Payments to Examiners and Assessors who are medically qualified

With effect from 1 January 2023

In December 2021 the General Board published a Notice regarding payments to Examiners, Assessors, and Supervisors who are not medically qualified (*Reporter*, 6640, 2021–22, p. 164). The purpose of the changes to such payments was to put in place a simpler, more transparent, and fairer set of payment rates to reward the work done, and to reflect more appropriately the amount of time taken to examine students' work. The Notice also indicated that the Board had agreed to recommend that the payments should be as determined by the Board from time to time and published in the *Reporter*, but that the individual rates should no longer require specific approval by Grace, and that all such payments should be governed by one Ordinance. The Board agreed that a separate schedule of rates should be developed for those who are medically qualified with relevant professional registration, which in this context refers to registration with the General Medical Council, the Nursing and Midwifery Council and the Health and Care Professions Council.

Accordingly, the Faculty Board of Clinical Medicine reviewed Examiner and Assessor payment rates for Final M.B. Examinations, and for Second M.B. Examinations in Preparing for Patients. The latter is a programme of study which provides medical students with early patient contact. The Faculty Board approved a proposal to set payment rates with reference to the consultant salary scale, mirroring the University's approach for setting rates for non-medically qualified Examiners with reference to the Single Salary Spine. The amount of time taken to prepare for examinations and to assess work was reviewed, and comparisons were made, for example, with external Examiner payment rates for clinical examinations, at other institutions.

The General Board, on the recommendation of the Faculty Board of Clinical Medicine, has approved the revised payment rates for Examiners and Assessors who are medically qualified as set out in Annex A. These changes take effect from 1 January 2023.

ANNEX A

The following new section has been added to the General Board's Schedule to the Ordinance on Payments to Examiners, Assessors and Supervisors (*Statutes and Ordinances*, p. 261) and a new heading for 'Payments to Examiners, Assessors and Supervisors who are not medically qualified' inserted above the current parts of the Schedule.

PAYMENTS TO EXAMINERS AND ASSESSORS WHO ARE MEDICALLY QUALIFIED

The table below sets out the rates for examination for the Second M.B. Examination in Preparing for Patients, and for all parts of the Final M.B. Examination. These examinations are assessed at the hourly rate (using a 46-week working year) for point 2 of the clinical consultant salary scale. Medically qualified Examiners and Assessors are those with relevant professional registration with the General Medical Council, the Nursing and Midwifery Council, or the Health and Care Professions Council.
