Amending Statutes for Trinity College

17 May 2023

The Acting Vice-Chancellor gives notice that he has received from the Governing Body of Trinity College, in accordance with the provisions of Section 7(2) of the Universities of Oxford and Cambridge Act 1923, the text of proposed Statutes to amend the Statutes of the College. The current Statutes of the College and the proposed amendments are available on the College's website at https://www.trin.cam.ac.uk/about/publication-scheme/ and https://www.trin.cam.ac.uk/about/college-notices/proposed-amending-statutes-march-2023/.

The Council will consider the amendments after 10 a.m. on Thursday, 8 June 2023.

Elections to the Board of Scrutiny and to the Nominating Committee for External Members of the Council

23 May 2023

This Notice announces elections to the Board of Scrutiny and the Nominating Committee for External Members of the Council and provides information on the nomination procedure and a timetable for those elections.

The University is committed to a proactive approach to equality, which includes supporting and encouraging all under-represented groups, promoting an inclusive culture, and valuing diversity. Nominations from groups that are under-represented on the Board of Scrutiny and the Nominating Committee are welcomed.

Board of Scrutiny

The Acting Vice-Chancellor gives notice of an election to fill vacancies on the Board of Scrutiny under Statute A VII as follows:

- **one vacancy** in class (c)(i) (a member of the Regent House who has been a member of the Regent House for not more than ten years on 1 October 2023); and
- three vacancies in class (c)(ii) (members of the Regent House).

Those elected would serve for four years from 1 October 2023.

The Board of Scrutiny consists of:

- (a) the Proctors;
- (b) the two Pro-Proctors nominated by the Colleges;
- (c) eight members of the Regent House elected by the Regent House.

Under the provisions of Statute A VII 4, no person may be a member of the Board of Scrutiny who is a member of the Council, the General Board, or the Finance Committee of the Council, or who holds any of the University offices of Chancellor, Vice-Chancellor, Pro-Vice-Chancellor, University Advocate, Deputy University Advocate, Registrary, Assistant Registrary, or Secretary of a School. The Statute further prohibits from membership holders of offices with primarily administrative duties designated by Ordinance: Directors and Deputy Directors in the Unified Administrative Service and Assistant Treasurers have been designated as such prohibited offices. A retiring member of the Board who has served for four or more consecutive years is not eligible to serve again as a member in class (c) until one year has elapsed after the end of that previous period of service.

If no nominations are received in accordance with the timetable below, the Council shall be asked whether it wishes to appoint a member to the vacant place or for another election to be held, in accordance with Regulation 3 of the regulations for the election of members of the Board (*Statutes and Ordinances*, p. 120).

Nominating Committee for External Members of the Council

The Acting Vice-Chancellor gives notice of an election to fill vacancies on the Nominating Committee for External Members of the Council as follows:

- **one vacancy** in class (c) (a member elected by the Regent House from among those who at the time of election are current members of Council in classes (a), (b) and (c));
- three vacancies in class (d) (members of the Senate elected by the Regent House).

No person may be a member of the Committee in class (d) who is a member of the Council or who holds any of the University offices of Pro-Vice-Chancellor, Registrary, or Director or Deputy Director in the University Offices.

One person elected in class (*d*) would serve with immediate effect until 30 September 2025, the remainder of the period of appointment of Dr Louise Joy, who was elected to the Council from 1 January 2023 and therefore stepped down from the Committee from that date. Others elected would serve for two years from 1 October 2023. Those elected in class (*d*) will be consulted before publication of a Grace proposing the periods of their appointments.

The Committee identifies candidates to serve as external members of Council and recommends them to the Council for appointment by Grace. There are no vacancies for external Council members at present and therefore no meetings are currently scheduled. Further information about the Committee is available in the *Statutes and Ordinances* (p. 119) and from the Registrary (email: Registrary@admin.cam.ac.uk).

Nomination procedure and election timetable

In order to be eligible, candidates for election are asked to send their nominations to the Acting Vice-Chancellor, to be received not later than 12 noon on Thursday, 15 June 2023. The Acting Vice-Chancellor asks candidates to address their nominations to the Registrary by email including electronic signatures to Registrary@admin.cam.ac.uk. The nomination, which can be made on a form available on the governance site, 1 should include (a) a statement signed by two members of the Regent House, nominating the candidate for election and specifying the class in which the candidate is nominated, and (b) a statement signed by the candidate confirming consent to be nominated. The candidate is also required to provide a personal statement by the same date (see below). No-one may be nominated for election in more than one class.

Each statement should be no more than 500 words in length and should cover the following points:

- the candidate's present position in the University;
- previous posts held, whether in Cambridge or in other universities or outside the university system, with dates;
- the candidate's reasons for standing for election, and the experience and skills they would bring to the role;
- a note of the candidate's particular interests within the field of University business.

The complete list of nominations will be published in the *Reporter* on 21 June 2023 and on the *Reporter* website before that. If an election is contested, it will be conducted by ballot under the Single Transferable Vote regulations. Online voting will open at 10 a.m. on Tuesday, 27 June and close at 5 p.m. on Friday, 7 July 2023. Hardcopy voting papers and supporting materials will be distributed not later than Tuesday, 27 June to those who opted to vote on paper; the last date for the return of voting papers is 5 p.m. on Friday, 7 July 2023.

REGULATIONS FOR EXAMINATIONS

Law Tripos

(Statutes and Ordinances, p. 381)

With effect from 1 October 2023

The General Board, on the recommendation of the Faculty Board of Law, has approved an amendment to the regulations for the Law Tripos, as follows:

Regulation 17.

GROUP IV

By adding a footnote to suspend Paper 43 Commercial law for the 2023-24 academic year.

Natural Sciences Tripos

(Statutes and Ordinances, p. 415)

With effect from 1 October 2023

The General Board, on the recommendation of the Committee of Management for the Natural Sciences Tripos, has approved the amendment of the regulations for the Natural Sciences Tripos to (i) remove the subject 'Psychology, Neuroscience, and Behaviour' as a distinct Part II subject, hosting students instead within the remaining single-discipline Part II subjects; and (ii) to amend the examination requirements for Earth Sciences in Part II of the Tripos.

Regulation 9.

By removing 'Psychology, Neuroscience, and Behaviour' from the list of examinable subjects in Part II nominated by the Faculty Board of Biology.

Regulation 26.

By removing 'Psychology, Neuroscience, and Behaviour' from the list of available subjects.

Regulation 30.

Earth Sciences

By amending sub-section (a) for the subject Earth Sciences, so that it reads (in its entirety) as follows:

- (a) three courses, chosen from a list of at least five, to be assessed by
 - (i) three written papers of two hours each, one associated with each of the three courses offered; and
 - (ii) three practical examinations or continuously assessed practical work, one associated with each of the three courses offered;

Psychology, Neuroscience, and Behaviour

By removing the examination requirements for the subject 'Psychology, Neuroscience, and Behaviour' in their entirety.

The General Board is confident that no candidate's preparation for the examination will be adversely affected by the changes.

Master of Accounting

(Statutes and Ordinances, p. 452)

With effect from 1 October 2023

The General Board, on the recommendation of the Faculty Board of Business and Management, has approved the amendment of the regulations for the Master of Accounting Examination to change the course title for Option B to include the word Executive, as follows:

Regulation 12.

By amending the course title for Option B to read as follows:

Option B: Executive Master of Accounting two-year (part-time) course

Master of the Conservation of Easel Paintings

(Reporter, 6675, 2022-23, p. 114)

With effect from 1 October 2023

The General Board, on the recommendation of the Faculty Board of Architecture and History of Art, has agreed to suspend entry to the degree of Master of the Conservation of Easel Paintings for one year and has approved the addition of a footnote to the regulations to indicate the suspension for the 2023–24 academic year.

History and Philosophy of Science and Medicine for the M.Phil. Degree

(Statutes and Ordinances, p. 532)

With effect from 1 October 2023

The General Board, on the recommendation of the Degree Committee for the Department of History and Philosophy of Science, has approved the amendment of the special regulations for the examination in History and Philosophy of Science and Medicine for the degree of Master of Philosophy by Advanced Study to reduce the number of essays required from three to two and change the word limit for one of the essays, as follows:

Regulation 1.

By amending sub-paragraph (b) to read as follows:

- (b) two essays, one of not more than 5,000 words, and one of not more than 8,000 words, including footnotes but excluding bibliography, and, except as provided below, each on a subject approved by the Degree Committee which is related to one or more of the following areas:
 - 1. Ancient, medieval, and early modern sciences
 - 2. Ancient, medieval, and early modern medicine
 - 3. Sciences in the age of empire, c. 1750–1900
 - 4. Modern medicine and biomedical sciences
 - 5. Modern sciences
 - 6. Metaphysics, epistemology, and the sciences
 - 7. Ethics and politics of medicine and the sciences
 - 8. Philosophy of the physical sciences
 - 9. Philosophy of biology and the life sciences
 - 10. Philosophy of social and cognitive sciences

Not more than one essay shall be chosen from any one area, except with the permission of the Degree Committee, who may allow two essays to be offered in one area, or one of the two essays to be offered in an area which is not listed above but is related to History, Philosophy, Sociology of Science, Technology, and Medicine.

END OF THE OFFICIAL PART OF THE 'REPORTER'

REPORT OF DISCUSSION

Tuesday, 16 May 2023

A Discussion was convened by videoconference with Deputy Vice-Chancellor Professor Simon Franklin, *CL*, presiding and the Registrary's deputy, the Senior Proctor and the Senior Pro-Proctor as the attending officers.

Remarks were received as follows:

Joint Report of the Council and the General Board, dated 3 May 2023, on changes to the University's Dignity at Work Policy and Grievance Policy

(Reporter, 6698, 2022–23, p. 635).

Professor G. R. Evans (Emeritus Professor of Medieval Theology and Intellectual History):

Deputy Vice-Chancellor, there were indeed 'missteps in the launch of previous versions' of these two policies. It is a pity that the proposed new versions are included only by way of a URL. Digital links inevitably lack the permanence of the historical record provided by text published in the *Reporter* itself.

The proposed replacements rely on a notion of 'acceptable behaviour within the University'. The Report's emphasis is on 'the University' as a 'workplace'. In particular the 'University's commitment to freedom of speech' is placed alongside 'its responsibility to provide a workplace free from harassment and discrimination'. These commitments are not easily reconciled and especially where their application to students is not thought through alongside their application to employees.

The Higher Education (Freedom of Speech) Act has now received royal assent and adds to the powers and duties of the Office for Students. But while the Report's proposals seek to bring together a wide range of 'inappropriate' behaviour, covering 'issues of bullying, harassment, discrimination, sexual misconduct and victimisation', the OfS is busy developing its requirements only in a more limited range of areas. Its consultation on those closed on 4 May 2023.

The Report expresses a concern that the University may fail to meet OfS Conditions of Registration if it does not keep up with OfS requirements. But the OfS is concerned only with students and it is asking for only 'clear definitions of harassment and sexual misconduct' and a 'single document' explaining how it is all to be handled with 'substantive enforceable obligations' on universities and colleges'. It remains to be seen exactly what will become the new Conditions of Registration.

The Report notes that 'amendments' may need to be made to align these policies with the proposed new ongoing condition of registration'. So perhaps there should not be too much of a hurry to implement these proposals, which seem likely to need further adjustment in the near future so as to meet these changing requirements?
