### Sir Robert Rede's Lecture

The Vice-Chancellor gives notice that the 2024 Rede Lecture will be given by Professor Dame Mary Beard, DBE, FSA, FBA, Fellow of Newnham College and Professor of Classics Emerita. The lecture will be given on **Friday, 3 May 2024 at 5.30 p.m.** in West Road Concert Hall. Tickets will be issued and booking arrangements as well as the title of the lecture will be confirmed in due course.

### Notice of a benefaction

The Vice-Chancellor gives notice that she has accepted with gratitude a benefaction from Cambridge in America of the value of 1,750,011 shares of Class A common stock of Dolby Laboratories, with the aim of transferring stock valued at US\$87,500,537, payable over up to 15 years, following a donation from the Ray Dolby Legacy Fund. The benefaction will support (i) an annual symposium to enhance public understanding of and broad academic engagement with physics, and teaching and research in physics, and (ii) six new research teams in the Department of Physics. Just over three quarters of the benefaction will be divided between four endowment funds to support Dolby Family Professorships (US\$31,850,196), post-doctoral research fellowships (US\$19,862,622), postgraduate studentships (US\$15,925,098), and an annual symposium and teaching and research (US\$3,937,523). A further US\$15,925,098 will provide start-up funding for the six research teams led by the holders of the Dolby Family Professorships. The Council is submitting a Grace (Grace 1, p. 456) to establish regulations for the Dolby Family Funds for Excellence in Physics.

## Change to the monetary threshold for the automatic referral of benefactions to the Committee on Benefactions and External and Legal Affairs

19 March 2024

The terms of reference for the University's Committee on Benefactions and External and Legal Affairs (CBELA) require that it advises the Vice-Chancellor in respect of the reputational risk of accepting all prospective donations to the University over £1m. This threshold is drawn from the Council's Notice providing *Ethical guidelines on the acceptance of benefactions* (reproduced in *Statutes and Ordinances*, p. 1049). Due to economic factors such as inflation, and a substantial ramp-up in fundraising operations over the last two decades, donations of over £1m are now much more common, and attract significantly less media attention, than when the £1m threshold was initially set in 2001. The Council, on the recommendation of CBELA, has therefore approved increasing this threshold to £4m with respect to benefactions which carry a low level of reputational risk for the University.

Under these new arrangements, items that fall under the £4m threshold but are likely to give rise to significant public interest, posing a higher level of reputational risk to the University, will continue to be referred to CBELA, and will continue to receive the same level of scrutiny as they do at present. The ethical guidelines will continue to apply to the acceptance of all other benefactions falling below the £4m threshold. The ethical guidelines will be updated to refer to the new threshold for all benefactions of £4m and over in paragraph 1 and to benefactions worth less than £4m in paragraph 2.

The University and Staff Joint Board (*Statutes and Ordinances*, p. 128) was established following the approval of the recommendations in the Joint Report of the Council and the General Board, dated 28 June 2022, on the establishment of the Board by Grace 1 of 28 September 2022 (*Reporter*: 6664, 2021–22, p. 575; 6669, 2022–23, p. 14).

The USJB provides a forum for meaningful consultation between the staff trade unions (Unite the Union, Unison and the University and College Union) and the University of matters regarding the employment of all University Staff. ## REGULATIONS FOR EXAMINATIONS

### Chemical Engineering Tripos

(*Statutes and Ordinances*, p. 294)

#### With effect from 5 January 2024

The General Board, on the recommendation of the Chemical Engineering and Biotechnology Syndicate, has approved an amendment of the regulations for the Chemical Engineering Tripos to alter the length of written examinations for Group A topics. The General Board is satisfied that no candidate's preparation for the exam will be affected by the change.

Regulation 15(b).

By replacing the words 'of two hours' duration' with 'of one and a half hours' duration' in Regulation 15(b).

### Human, Social and Political Sciences Tripos

(*Statutes and Ordinances*, p. 369)

#### With effect from 1 October 2024

The General Board, on the recommendation of the Faculty Board of Human, Social and Political Science, has approved the amendment of the regulations for the Human, Social and Political Sciences Tripos to prohibit a student taking Papers SOC5 and POL6 in consecutive years due to overlapping content, as follows:

Regulation 18.

By adding a footnote to the references to Paper POL6 in sub-paragraphs 18(a)(iii) (Politics and International Relations) and 18(d)(i) (Politics and Sociology) that reads 'Paper POL6 is only available to candidates if they did not take Paper SOC5 in Part IIa'.

### Law Tripos

(*Statutes and Ordinances*, p. 379)

#### With effect from 1 October 2024

The General Board, on the recommendation of the Faculty Board of Law, has approved amendments to the regulations for the Law Tripos to amend certain paper details, as follows:

Regulation 17.

By amending the title of Paper 10 in Group I from *Civil law I* to *Civil law in context*.

By amending the title of Paper 30 in Group III from *Civil law II* to *Advanced civil law*.

And by adding a footnote to Paper 42, *Competition law*, in Group IV to suspend it for the 2024–25 academic year.

### Master of Law (LL.M.) Examination

(*Statutes and Ordinances*, p. 466)

#### With effect from 1 October 2024

The General Board, on the recommendation of the Faculty Board of Law, has approved an amendment to the regulations for the LL.M. Examination to change the title of the field Intellectual Property to *Intellectual Property, Technology and Information Law* to widen the field of study. The title of the field in Regulation 1 will be updated accordingly.

## Cognitive Neuroscience for the M.Phil. Degree

### With effect from 1 October 2024

The General Board, on the recommendation of the Faculty Board of Clinical Medicine, has approved Cognitive Neuroscience as a course of study for the degree of Master of Philosophy by Advanced Study with effect from 1 October 2024. Special regulations for the examination have been approved as follows:

#### COGNITIVE NEUROSCIENCE

1. The scheme of examination for the one-year course of study in Cognitive Neuroscience for the degree of Master of Philosophy shall consist of:

- (a) a biostatistics assessment;
- (b) a written paper of two hours' duration;
- (c) an essay of no more than 2,500 words in length comparing three contrasting research papers, on a topic chosen from a specified list;
- (d) a dissertation on an individual research project, on a topic proposed by the candidate and subject to the approval of the Degree Committee for the Faculties of Clinical Medicine and Veterinary Medicine, comprising
  - (i) a literature review of the relevant field providing background to and context for the research project, of no more than 5,000 words in length (excluding tables, footnotes, appendices, and bibliography); and
  - (ii) an account of the methods and outcomes of the research project, of no more than 5,000 words in length (excluding tables, footnotes, appendices, and bibliography);
- (e) a poster presentation on the research project;
- (f) an oral presentation on a research technique, on a topic chosen by the candidate and subject to the approval of the Degree Committee.

2. The list of research papers available to candidates under Regulation 1(c) shall be published by the Degree Committee no later than the end of the Michaelmas Term of the academic year in which the examination is to be held.

3. The examination may include, at the discretion of the Examiners, an oral examination on the work submitted by the candidate under Regulation 1(c) to (f) and on the general field of knowledge within which such work falls.

## Latin-American Studies for the M.Phil. Degree

### With effect from 1 October 2024

The General Board, on the recommendation of the Degree Committee for the Department of Politics and International Studies, has approved the amendment of the special regulations for the course in Latin-American Studies for the degree of Master of Philosophy as follows:

Regulation 1(b).

By removing the words ‘, from the following list of modules:’ and the list of named modules from the text of Regulation 1(b).

## Molecular Mechanisms of Human Disease for the M.Phil. Degree

### With effect from 1 October 2024

The General Board, on the recommendation of the Faculty Board of Clinical Medicine, has approved Molecular Mechanisms of Human Disease as a course of study for the degree of Master of Philosophy by Advanced Study with effect from 1 October 2024. Special regulations for the examination have been approved as follows:

#### MOLECULAR MECHANISMS OF HUMAN DISEASE

1. The scheme of examination for the one-year course of study in Molecular Mechanisms of Human Disease for the degree of Master of Philosophy shall consist of:

- (a) a biostatistics assessment;
- (b) a written paper of two hours' duration;
- (c) a dissertation on an individual research project, on a topic proposed by the candidate and subject to the approval of the Degree Committee for the Faculties of Clinical Medicine and Veterinary Medicine, comprising

- (i) a literature review of the relevant field providing background to and context for the research project, of no more than 5,000 words in length (excluding tables, footnotes, appendices, and bibliography); and
  - (ii) an account of the methods and outcomes of the research project, of no more than 5,000 words in length (excluding tables, footnotes, appendices, and bibliography);
  - (d) a poster presentation on the research project;
  - (e) an oral presentation on a research technique, on a topic chosen by the candidate and subject to the approval of the Degree Committee.
2. The examination may include, at the discretion of the Examiners, an oral examination on the work submitted by the candidate under Regulation 1(c) to (e) and on the general field of knowledge within which such work falls.

## Obesity, Endocrinology and Metabolism for the M.Phil. Degree

### With effect from 1 October 2024

The General Board, on the recommendation of the Faculty Board of Clinical Medicine, has approved Obesity, Endocrinology and Metabolism as a course of study for the degree of Master of Philosophy by Advanced Study with effect from 1 October 2024. Special regulations for the examination have been approved as follows:

#### OBESITY, ENDOCRINOLOGY AND METABOLISM

1. The scheme of examination for the one-year course of study in Obesity, Endocrinology and Metabolism for the degree of Master of Philosophy shall consist of:
- (a) a biostatistics assessment;
  - (b) a written paper of two hours' duration;
  - (c) an essay of no more than 2,500 words in length comparing three contrasting research papers, on a topic chosen from a specified list;
  - (d) a dissertation on an individual research project, on a topic proposed by the candidate and subject to the approval of the Degree Committee for the Faculties of Clinical Medicine and Veterinary Medicine, comprising
    - (i) a literature review of the relevant field providing background to and context for the research project, of no more than 5,000 words in length (excluding tables, footnotes, appendices, and bibliography); and
    - (ii) an account of the methods and outcomes of the research project, of no more than 5,000 words in length (excluding tables, footnotes, appendices, and bibliography);
  - (e) a poster presentation on the research project;
  - (f) an oral presentation on a research technique, on a topic chosen by the candidate and subject to the approval of the Degree Committee.

## Connected Electronic and Photonic Systems for the M.Res. Degree

(Statutes and Ordinances, p. 544)

### With effect from 1 October 2024

The General Board, on the recommendation of the Faculty Board of Engineering, has approved a change to the title of the course of study for the degree of Master of Research in Connected Electronic and Photonic Systems to *Photonic and Electronic Systems*. The title of the special regulations for the course and text of Regulation 1 will be updated accordingly.



## Sensor Technologies and Applications for the M.Res. Degree

(*Statutes and Ordinances*, p. 547)

### With effect from 1 October 2024

The General Board, on the recommendation of the Faculty Board of Engineering, has approved the suspension of the course of study in Sensor Technologies and Applications for the degree of Master of Research for the 2024–25 academic year. The special regulations for the course will be footnoted accordingly.

## Crime and Thriller Writing for the M.St. Degree: Correction

(*Statutes and Ordinances*, p. 556)

### With effect from 1 October 2024

The Notice published on 13 March 2024 (*Reporter*, 6734, 2023–24, p. 443) unfortunately contained an error. The General Board has approved the *suspension* of the course in Crime and Thriller Writing for the degree of Master of Studies for one year from 1 October 2024 and not its withdrawal. The special regulations will be footnoted accordingly.

## Postgraduate Diploma in Legal Studies and Postgraduate Diploma in International Law

(*Statutes and Ordinances*, p. 579)

### With effect from 1 October 2024

The General Board, on the recommendation of the Faculty Board of Law, has approved the suspension of both the Postgraduate Diploma in Legal Studies and the Postgraduate Diploma in International Law for the 2024–25 academic year. **1.** That the Dolby Family Funds for Excellence in Physics be established in the University, to be governed by the following regulations:<sup>1</sup>

**DOLBY FAMILY FUNDS FOR EXCELLENCE IN PHYSICS**

**1.** The funds received from Cambridge in America, following a donation from the Ray Dolby Legacy Fund, together with such other sums as may be received or applied for the same purpose, shall form a series of four endowment funds called: (a) the Dolby Family Fund for Excellence in Physics Professorships to support Dolby Family Professorships and other academic offices; (b) the Dolby Family Fund for Excellence in Physics Fellowships to support post-doctoral research fellowships in the Department of Physics; (c) the Dolby Family Fund for Excellence in Physics Postgraduate Studentships to support postgraduate studentships in Physics; and (d) the Dolby Family Fund for Excellence in Physics Engagement, Teaching, Research and Symposiums to support an annual symposium, teaching, and research in Physics.

**2.** The Managers shall be responsible for the administration of the Funds and the application of the income of each respective Fund and shall comprise the Head of the School of the Physical Sciences, who shall be Chair, the Head of the Department of Physics, and the Ray Dolby Professor of Physics.

*A. Dolby Family Fund for Excellence in Physics  
Professorships*

**1.** The income of the Fund shall be applied towards the payment of the stipend, national insurance, pension contributions, and associated indirect costs of one or more Professorships and other academic offices in the Department of Physics, the number and level of the offices to be as determined by the Managers after having regard to the income available and the long-term sustainability of the Fund. The holders of the offices shall lead their own Dolby Family research team in their particular area of expertise.

**2.** Any unexpended income in any financial year, including income accrued during a vacancy in any of the Professorships or academic offices, may, at the discretion of the Managers, be carried forward for use as income in accordance with Regulation 1 in any one or more subsequent financial years, including the support of an additional Professorship and/or academic office.

*B. Dolby Family Fund for Excellence in Physics  
Fellowships*

**1.** The income of the Fund shall be applied towards the provision of Dolby Family Research Fellowships in the respective Dolby Family research team, the holders of which shall be appointed by the Managers, in accordance with criteria and for a period of tenure and a stipend determined by the Managers, the stipend within a range approved from time to time by the General Board. The Managers shall appoint at least one Fellowship per Dolby Family research team from the income of the Fund in any financial year and may not appoint more than one Fellowship in a Dolby Family research team without the consent of all those appointed as Dolby Family Professors.

**2.** Any unexpended income in any financial year may, at the discretion of the Managers, be carried forward for use as income in accordance with Regulation 1 in any one or more subsequent financial years, including the support of additional Fellowships.

*C. Dolby Family Fund for Excellence in Physics  
Postgraduate Studentships*

1. The income of the Fund shall be applied towards the provision of Dolby Family Postgraduate Studentships to support Ph.D. students undertaking research in the respective Dolby Family research teams in such manner as the Managers shall determine, provided that there shall be no more than two such Studentships held in each research team at any one time without the consent of all those appointed as Dolby Family Professors.

2. Any unexpended income in any financial year may, at the discretion of the Managers, be carried forward for use as income in accordance with Regulation 1 in any one or more subsequent financial years, including the support of additional Studentships.

*D. Dolby Family Fund for Excellence in Physics  
Engagement, Teaching, Research and Symposiums*

1. The income of the Fund shall be applied to support teaching and research in physics, and an annual symposium to enhance public understanding of and broad academic engagement with physics, in such manner as may be determined by the Managers.

2. Any unexpended income in any financial year may, at the discretion of the Managers be carried forward for use as income in accordance with Regulation 1 in any one or more subsequent financial years.

2. That Regulation 9 of the Ordinance for the election of members of the Council (*Statutes and Ordinances*, p. 118) be amended to read as follows:<sup>2</sup>

9. For the purposes of Special Ordinance A (iii), the term ‘student in the University’ shall mean any person eligible to vote in elections for the office of President as governed by the articles of association of the University of Cambridge Students’ Union as determined from time to time, or who would be so eligible but who has resigned their membership of the Union, and who is not a sabbatical officer-elect or sabbatical officer of that Students’ Union nor standing for election to such an office.
