Report of the Council on the office of Chief Financial Officer: Notice in response to Discussion remarks

9 January 2025

The Council has received the remarks made at the Discussion on 10 December 2024 on the above Report (*Reporter*, 2024–25: 6759, p. 117; 6764, p. 199).

Dr Astle queries the constitutional consistency of the Chief Financial Officer being accountable to the Council through the Vice-Chancellor, noting the Council's duty to exercise general supervision over the University's finances. As the Chair of the Council, the Vice-Chancellor is the person best placed to provide guidance to the Chief Financial Officer on behalf of the Council.

Dr Astle also suggests that the title of Treasurer should be adopted instead of Chief Financial Officer, to indicate the subordination of good financial management to the University's academic activity. Following a similar line of thought, after surveying developments since 1998, Professor Evans concludes that a Report on the place and character of 'leadership' in the University would be helpful in enabling the Regent House to clarify its definition. The key components of the updated office of Chief Financial Officer are as set out in the current Report, therefore the Council sees no need for any additional Report. The Council understands that the title of Chief Financial Officer is now more widely used within the HE sector than that of Treasurer and has much higher recognition among suitably qualified potential applicants. The further particulars for the office will include information about the University context, including the roles of the Regent House and the Council.

The Council is submitting a Grace (Grace 1, p. 227) for the approval of the recommendations of this Report.

¹ Raising a matter not directly related to this Report, Dr Astle questions the statement in the Council's Notice of 7 November 2024 stating that it has 'sole responsibility for decisions about investments, and therefore the Grace would not be binding on the Council if approved by the Regent House' based on the cited parts of Statute and Special Ordinance. The Council agrees that the Notice should also have referred to the Council's executive powers under Statute A IV 1(a) for the management of the University's resources.

Joint Report of the Council and the General Board on the disbanding of the University Theatre Syndicate: Notice in response to Discussion remarks

9 January 2025

The Council has received the remarks made at the Discussion on 10 December 2024 concerning the above Report (*Reporter*, 2024–25: 6761, p. 141; 6764, p. 200). It has consulted with the General Board in preparing this response.

The Council agrees with Professor Evans that, where a body is established in Statute or Ordinance, the key difference between a Committee and a Syndicate or a Board lies in the ability of the latter to report directly to the Regent House by publishing a Report. However, there are other mechanisms that Committee members and others can use to draw attention to issues. For example, any ten members of the Regent House can request the discussion of a Topic of concern to the University, after which any remarks made will be published in the *Reporter* and the Council required to publish a response to them.

The arrangements for the ADC Theatre as a General Board institution and for the new Committee, as set out in the new General Board Regulations, follow the pattern of those for similar institutions and their related committees that are also under the supervision of the General Board.

The Council is submitting a Grace (Grace 2, p. 227) for the approval of the recommendations of this Report.

REGULATIONS FOR EXAMINATIONS

Award of a lower degree for certain doctoral degrees

With effect from 1 January 2025

The General Board, on the recommendation of the Postgraduate Committee in consultation with the relevant Degree Committees, has approved the amendment of the regulations for certain doctoral degrees to streamline the process and timeline for awarding a lower degree. The following regulations are amended with effect from 1 January 2025:

- (a) Doctor of Business (Statutes and Ordinances, p. 451): By amending Regulation 13 to read as follows:
 - 13. If, after considering the reports of the Examiners, the Degree Committee considers that a student's work is not of the standard requisite for the Bus.D. Degree, but that it is of the standard requisite for the M.Sc. Degree, its recommendation shall be communicated to the General Board, together with the reports of the Examiners. If after receiving such communication the Board decides that the candidate could properly be approved for the award of the lower degree, the Registrary shall communicate this decision to the candidate and approve the candidate for the award of that degree. The Registrary shall publish a notice of such approval unless the candidate has requested the removal of their name from the published list in accordance with a procedure approved from time to time by the General Board.
- (b) Doctor of Education (Statutes and Ordinances, p. 461): By amending Regulation 13 to read as follows:
 - 13. If, after considering the reports of the Examiners, the Degree Committee considers that a student's work is not of the standard requisite for the Ed.D. Degree, but that it is of the standard requisite for the M.Litt. Degree, its recommendation shall be communicated to the General Board, together with the reports of the Examiners. If after receiving such communication the Board decides that the candidate could properly be approved for the award of the lower degree, the Registrary shall communicate this decision to the candidate and approve the candidate for the award of that degree. The Registrary shall publish a notice of such approval unless the candidate has requested the removal of their name from the published list in accordance with a procedure approved from time to time by the General Board.
- (c) Doctor of Philosophy, Master of Science, Master of Letters, and Master of Philosophy by Thesis (*Statutes and Ordinances*, p. 497): By amending Regulation 16 to read as follows:
 - 16. If, after considering the reports of the Examiners, the Degree Committee considers that a student's work is not of the standard requisite for the Ph.D. Degree, but that it is of the standard requisite for the M.Sc. or M.Litt. Degree, its recommendation shall be communicated to the General Board, together with the reports of the Examiners. If after receiving such communication the Board decides that the candidate could properly be approved for the award of the lower degree, the Registrary shall communicate this decision to the candidate and approve the candidate for the award of that degree. The Registrary shall publish a notice of such approval unless the candidate has requested the removal of their name from the published list in accordance with a procedure approved from time to time by the General Board.

- (d) Doctor of Veterinary Medicine (Statutes and Ordinances, p. 575): By amending Regulation 13 to read as follows:
 - 13. If, after considering the reports of the Examiners, the Degree Committee considers that a student's work is not of the standard requisite for the Vet.M.D. Degree, but that it is of the standard requisite for the M.Sc. Degree, its recommendation shall be communicated to the General Board, together with the reports of the Examiners. If after receiving such communication the Board decides that the candidate could properly be approved for the award of the lower degree, the Registrary shall communicate this decision to the candidate and approve the candidate for the award of that degree. The Registrary shall publish a notice of such approval unless the candidate has requested the removal of their name from the published list in accordance with a procedure approved from time to time by the General Board.

Doctor of Medicine

(Statutes and Ordinances, p. 478)

With effect from 1 January 2025

The General Board, on the recommendation of Postgraduate Committee and the Degree Committee for the Faculties of Clinical Medicine and Veterinary Medicine, has approved amendments to the regulations for the degree of Doctor of Medicine to allow approval of the M.Sc. Degree in lieu of the M.D. Degree, for consistency with examination outcomes for the Bus.D., Ed.D., Eng.D., Ph.D. and Vet.M.D. Degrees, as follows:

Regulations 14 to 19.

By replacing existing Regulations 14 to 17 with the following new or revised regulations:

- 14. The Degree Committee shall be the deciding authority on all decisions that candidates be approved for the award of the degree or that they be allowed to submit revised theses. The General Board shall be the deciding authority not to award the degree or to award a lower degree.
- 15. If, after considering the reports of the Examiners on a candidate's thesis and performance in the oral examination, the Degree Committee is satisfied that the candidate's work is of the requisite standard for the degree, showing evidence of significant original contribution to the advancement of the science, art, or history of medicine, its decision shall be communicated to the Student Registry, together with the reports of the Examiners. The Student Registry shall publish a notice of the candidate's approval for the award of the degree unless the candidate has requested the removal of their name from the published list in accordance with a procedure approved from time to time by the General Board.
- 16. If, after considering the reports of the Examiners of a thesis, the Degree Committee is of the opinion that a candidate's thesis is not of the requisite standard for the degree, the Degree Committee may permit the student to submit a revised thesis. The decision of the Degree Committee shall be communicated to the Student Registry, together with the reports of the Examiners. A student shall not be allowed to submit a revised thesis on more than one occasion.
- 17. If, after considering the reports of the Examiners, the Degree Committee is of the opinion that a candidate's work thesis is not of the requisite standard for the M.D. Degree, but that it is of the standard requisite for the M.Sc. Degree, its recommendation shall be communicated to the General Board, together with the reports of the Examiners. If after receiving such communication the Board decides that the candidate could properly be approved for the award of the lower degree, the Registrary shall communicate this decision to the candidate and approve the candidate for award of the M.Sc. Degree. The Registrary shall publish a notice of such approval unless the candidate has requested the removal of their name from the published list in accordance with a procedure approved from time to time by the General Board.
- 18. If after considering the reports of the Examiners the Degree Committee resolves that a candidate's work is not of the requisite standard for the degree, and if the Committee does not recommend that the candidate be allowed to submit a revised thesis, its recommendation shall be communicated to the General Board, together with the reports of the Examiners. If after receiving such communication the Board decides that the candidate could not properly be approved for the award of the degree, the Registrary shall communicate this decision to the candidate.
- 19. A candidate who is not approved for the M.D. Degree under Regulation 18 may apply to be a candidate for the M.D. degree by the Special Regulations, providing the candidate meets the eligibility requirements; such application may be made on not more than one occasion, after a period of not less than five years from the date of the applicant's original examination for the Degree.

- **3.** That in Regulation 5(c) of the Ordinance for Stipends (*Statutes and Ordinances*, p. 684) the grades for the holders of the offices of Professor (Grade 11) and Reader and the part of Note 4 of Schedule I about Professors (Grade 11) be revised from 1 October 2024, to read as follows:³

Professor (Grade 11) and Reader

Grade 11

points 63-67

[Note 4] Professors (Grade 11) will be appointed to Grade 11. From 1 October 2024, Professors (Grade 11) can be appointed between point 63 and point 67. Prior to this date, Professors (Grade 11) could only be appointed to point 2 in Grade 11 (spine point 63).

Additionally, that Note 4 of Schedule I be amended from 1 March 2025 to include the following:

[Note 4] The minimum for Professors at Grade 11 will be point 63 of Grade 11.

³ In August 2024, the Regent House approved changes to Schedule I of the Ordinance for Stipends, to remove the restrictions on contribution increments for academic staff at Grades 9, 10 and 11 as part of an interim pay and benefits package (*Reporter*, 6751, 2023–24, p. 856; changes to the salary scales were also approved in October 2024, *Reporter*, 6756, 2024–25, p. 58). However, a further change to the Ordinance was overlooked. The Council, on the recommendation of the General Board and the HR Committee, is proposing this change to remove the restrictions on contribution increments for academic staff at Grade 11, whilst retaining the starting point at spine point 63. The University's internal promotion rules will now apply to those being promoted to the office of Professor (Grade 11) and therefore on promotion, an individual will either move to spine point 63 or by two increments, whichever is the greater.
