University maternity leave and other family-related leave policy

27 February 2025

On 25 September, the Council and the General Board gave notice of changes to the University's policies on maternity and paternity leave (*Reporter*, 6752, 2024–25, p. 3). They have since approved an additional change to reflect current policy. The sentence on University paternity leave, as reproduced in *Statutes and Ordinances*, 2024, p. 679, has been revised to read as follows, with effect from 1 October 2024:

In the light of the right to paternity leave and pay under the Employment Act 2002, the Council and the General Board give notice of the existing, more favourable University paternity leave provision offered to eligible employees of up to twelve weeks on full pay.

University of Cambridge Financial Regulations: Correction

27 February 2025

There was an error in the Council's Notice of 25 July 2024 (*Reporter*, 6751, 2023–24, p. 858).¹ In Regulation 18.4(d) the thresholds included VAT, but they should have stated that they excluded VAT. Following correction, the text now reads as follows (revised wording shown in bold):

(d) The Chief Financial Officer's advice is needed for:

- procurement (other than construction) where the Total Value exceeds £100,000 **excluding** VAT if applicable;
- procurement where the Total Value exceeds £50,000 **excluding** VAT if applicable and supplier terms are used.

Topic of concern to the University: Support for the Veterinary course

4 March 2025

The Registry gives notice that she has received the following request for the discussion of a Topic of concern to the University:

Support for the veterinary course at the University, including questions of general principle regarding reasonable processes within the University

The General Board set up a Veterinary School Review Group in May 2023:

- to provide an objective perspective on the delivery of the Clinical Services Business;
- to provide a view on management and organisation of clinical services and the wider Department that exist in the support of teaching for the Veterinary Sciences Tripos, final Bachelor degree of Veterinary Medicine, and research;
- to research clinical educational needs and benchmark alternatives to our current delivery model.

That Review Group has produced a confidential interim report, but has yet to publish a final report. In the meantime, the Veterinary Programme in the University received a negative accreditation review from The Royal College of Veterinary Surgeons (RCVS). The RCVS has indicated that there would be further review in September 2025 to determine whether the Cambridge course would be accredited for the September 2026 intake.

In November 2024, the General Board wrote to the Head of Department of Veterinary Medicine, giving the Department around four weeks to outline a commitment to take forward work to develop an alternative option for clinical course delivery in partnership with one or more other clinical providers, or to indicate that this effort will not be pursued. In the former case, the proposed partners would need to be identified with their willingness to partner documented. Subsequently, the General Board wrote to the Department and asked for external assurance by early March 2025 that there was no likelihood of a terminal accreditation decision following the RCVS visit in September 2025, and that all RCVS recommendations could be appropriately addressed. The General Board suggested that it was minded to suspend the veterinary course, closing it to new entrants in 2026, if such assurance from the Department was not forthcoming.

As well as the future of the Vet.M.B. course, aspects of the above process are matters of concern.

- Was it reasonable for the General Board to ask the Department to develop an alternative option for clinical course delivery within four weeks when its own Review Group has, so far, taken over 20 months to report?
- Why did the General Board ask for an external assurance of accreditation from the Department, when that is in essence an impossible condition to meet six months before the RCVS return visit?

This request is supported by the 86 members of the Regent House listed in Annex A.

The Council has agreed that this topic will be included on the agenda of the Discussion on **Tuesday, 18 March 2025 at 2 p.m. by videoconference** (see p. 395).

Public consultation on the future planning application for North West Cambridge

The Estates Division is preparing a new planning application to support additional housing at the North West Cambridge development. The first phase of the development is called Eddington which is the centre of the residential community. Eddington is the University's response to the need to provide affordable housing for staff so it can attract and retain top talent to retain its global competitiveness.

The neighbourhood, which opened in 2017, includes affordable homes for University and College key workers, market homes for the community, student accommodation, and a range of social facilities, independent retail, infrastructure, and open space.

Outline planning permission for 3,000 homes, 2,000 student rooms, 100,000 sqm research space and associated infrastructure at North West Cambridge was granted in 2013. Planning permission for the residential homes has now lapsed and a new outline planning consent is required for any future homes to be delivered (excluding homes that currently have detailed planning consent and are under construction). There is the potential for the development site to accommodate more than 5,000 homes in the future in this sustainable location. Future phases will build on the successes of Eddington, deepening design principles and learning lessons, while ensuring that they support the academic and social goals of the University, with the aim of creating a vibrant, long-lasting and sustainable place.

To support the pre-application process, public consultations are being held for all members of the community. Attendance is encouraged and feedback will directly inform the development proposals. Subject to recommendation from the Council and approval by the Regent House anticipated to be requested in summer 2025, a new planning application to the local authorities will be submitted in autumn 2025.

REPORTS

Report of the Council on a new temporary facility for the Molecular Imaging Chemistry Laboratory at the Cambridge Biomedical Campus

The COUNCIL begs leave to report to the University as follows:

1. In this Report the Council is seeking approval for the submission of a full planning application and for the construction of a new temporary modular building in a location adjacent to the John Van Geest Centre for Brain Repair on the Forvie site at the Cambridge Biomedical Campus (CBC) to accommodate the Molecular Imaging Chemistry Laboratory (MICL). This Report's main recommendation replaces a proposal made in a Report in July 2024 for the temporary building to be situated in the East Forvie Car Park.¹ The Council has therefore withdrawn the July 2024 Report.

2. The project outlined in this Report ('Temporary building for the MICL') will replace the MICL's current accommodation with temporary accommodation in advance of a longer-term move in the future. The reasons for making this proposal have not changed since publication of the July 2024 Report and are repeated below. As the project remains urgent and consultation suggests both the project in principle and the proposed new location have broad support, this Report seeks approval for both the project and its construction in one stage. Therefore if planning permission is granted, there will be no second Report unless there are significant changes to the project as outlined below.

3. The School of Clinical Medicine has a strategic plan, based on its existing strengths in radiochemistry and positron emission tomography (PET), to create an internationally leading centre for molecular imaging on the CBC. The MICL is a dedicated preclinical facility for researchers from across the University to undertake research in the discovery, development and clinical translation of novel radiotracers for the biomedical technique of PET. It is a key component of the integrated PET imaging infrastructure.

4. The current accommodation for the MICL in the West Forvie Building (WFB) on the Forvie site is extremely unsatisfactory for a number of reasons:

- (a) Much of the Mechanical, Electrical and Public Health (MEPH) infrastructure is beyond or approaching the end of its life expectancy and at risk of operational failure and/or regulatory non-compliance with Environment Agency and other statutory quality and safety standards. If the MEPH failed, all experimental procedure, especially radiochemical procedure, would have to stop. This would risk serious disruption to the MICL and its research capabilities. If regulatory compliance failed, certain research activities, which support a number of Departments, may have to cease.
- (b) The building is ranked number one across the University's estate in the prioritisation list for the Decarbonising Heat Programme. As this programme gains momentum, there is likely to be increasing pressure to find a way to address the carbon emissions of the WFB.
- (c) Without significant alteration the building will not be able to accommodate new equipment and does not have the capacity for expansion of research programmes. For example, the MICL has identified the need for a new dedicated mini cyclotron, which would enable it to have more regular access to – and a wider range of – radioisotopes, and avoid the need to transfer the

radioisotopes batches from the Radiopharmaceutical Unit (RPU) facility that is situated within the basement of the nearby Wolfson Brain Imaging Centre (WBIC) and reaching its operational maximum.

- (d) The building does not provide an environment that is conducive to positive staff and student well-being. The WFB once housed biomedical facilities now relocated to the Anne McLaren Building and the Jeffrey Cheah Biomedical Centre. The MICL is therefore now the last remaining facility in a building that is otherwise empty in preparation for demolition. The poor working environment is impacting the retention and recruitment of staff to the MICL to support its research programmes.

5. Work started on a project (MICL 2) to provide long-term alternative accommodation for the MICL and proposals for a new, mixed commercial and academic building on the Forvie site were drawn-up. However, since then, other matters have intervened, forcing a rethink of the project and delays to the development of plans for a longer-term solution. These matters include the discovery of reinforced autoclaved aerated concrete within the West Forvie Building, which necessitated propping, further compromising an already poor working environment.

6. In December 2023, the Estates Committee endorsed the strategy to review the feasibility of temporary accommodation for the MICL before submission of the appropriate business case for a new permanent building.

7. A project to develop a 'Temporary building for the MICL' was therefore registered with the Planning and Resources Committee (PRC) in February 2024.

8. In July 2024, a proposal to locate the temporary facility on the East Forvie Car Park site was put forward. A Report was published on 2 July and an Outline Business Case (OBC) was prepared for Estates Committee and PRC review. Remarks were raised at Discussion in which concerns were raised about the suitability of the East Forvie Car Park location. In response to this, a Sub-committee (including members from each of the buildings on the Forvie site) of the Project Board was established and tasked with undertaking a review of the potential locations for the temporary facility.¹

9. An alternative location on the Forvie site, adjacent to the John Van Geest Centre for Brain Repair, was endorsed by the Project Board Sub-Committee and the Project Board in November 2024. The plan below shows the revised location of the proposed temporary building (see p. 400).

10. There are inherent inefficiencies in a strategy that involves double relocation. However, the scope that has been developed will accommodate the MICL in suitable laboratory and write-up space, where the requirements for the facility are based on the minimum viable product for the team to continue to operate over approximately a five-year period. This temporary solution is intended to provide the University with sufficient time to enable the issues with the longer-term plans to be resolved, for a strategy for the University's landholdings across the Cambridge Biomedical Campus to be developed, and for providing the MICL with appropriate long-term accommodation.

11. The Project Cost of the new temporary facility in the revised location is estimated to be £7.8m. This initial estimate will be refined during the next phase of design development, which will be undertaken through the procurement of a specialist modular contractor under a pre-construction services agreement.

12. The revised OBC has been endorsed by the Estates Committee and approved by the PRC. The urgent need for a replacement facility for the MICL means that approval from the Regent House is being sought via this single-stage Report, as noted above, and subject to determination of a Full Business Case later in 2025.

13. The Council recommends:

- I. That, subject to Estates Committee and Planning and Resources Committee approval of the Full Business Case for the project, approval be given for the construction of a new temporary facility for the Molecular Imaging Chemistry Laboratory on the Forvie site adjacent to the John Van Geest Centre for Brain Repair.
- II. That the Director of Estates be authorised to apply for full planning permission and to construct the facility in due course.

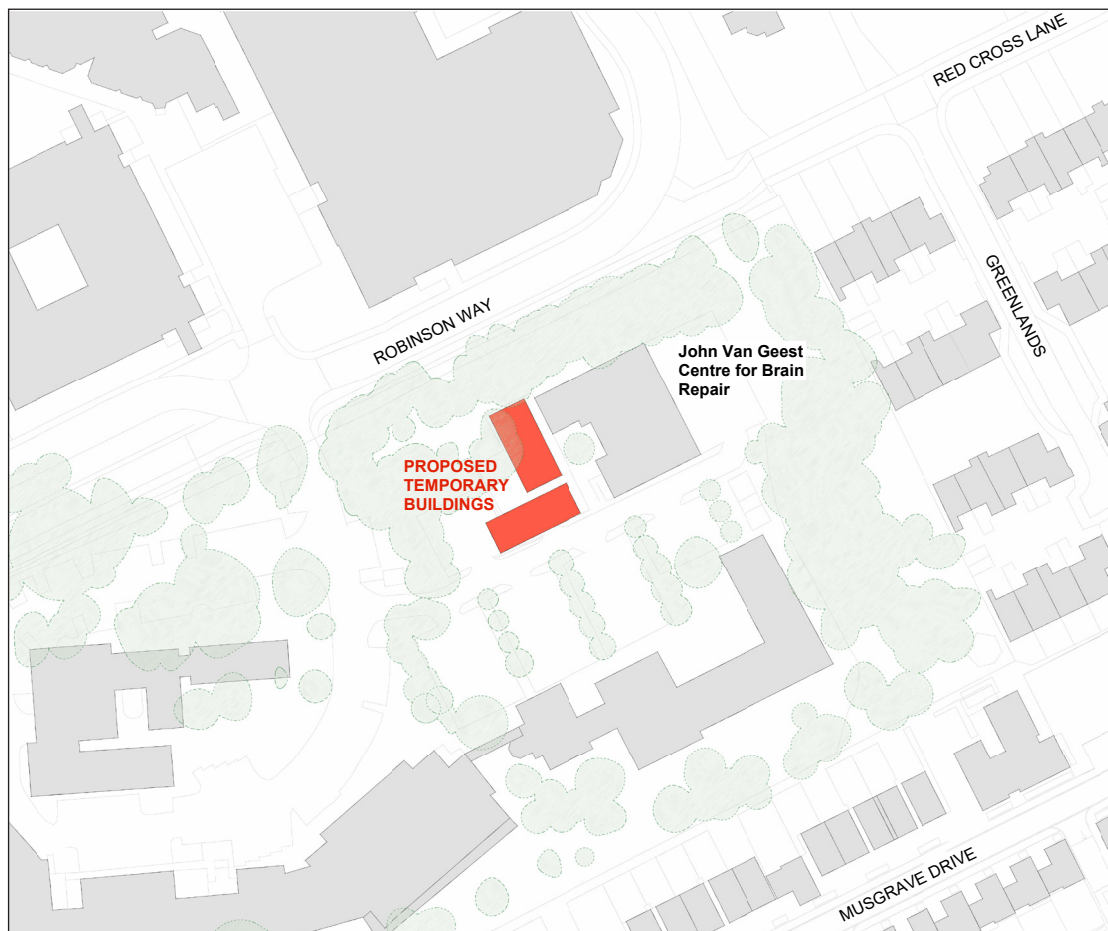

1. That Regulation 2(b) of the Ordinance for Forms of Admission to Degrees (*Statutes and Ordinances*, 2024, p. 175) be amended by the addition of the following words at the end:¹

provided that exceptionally and after consulting the Proctors, the person conferring degrees may also use these shortened formulae for admissions to doctoral degrees.

2. That Regulation 9 of the Ordinance for the Jebb Fund (*Statutes and Ordinances*, 2024, p. 884) be amended to read as follows:²

9. Any graduate of the University shall be eligible for a Studentship. A Student may be re-elected for a year at a time, subject to a maximum tenure of four years in all.

² The Council, on the recommendation of the General Board and the Electors of the Fund, is proposing this amendment to remove an age limit from the criteria for the Jebb Studentship. The age limit was inserted by the Council when proposing regulations for the Fund in 1931 and therefore is not part of the trust terms governing the use of the Fund. Its removal will enable the Electors to consider a wider pool of applicants for the Studentships.
