Grace 1 of 12 February 2025 (ACP (R) proposals): Notice of amendment

5 March 2025

The Vice-Chancellor gives notice that she has received a proposal for the amendment of Grace 1 of 12 February 2025, signed by 31 members of the Regent House as noted in the Annex below.

The proposed amendment is as follows:

1. That the recommendations in paragraph 12 of the Report of the General Board, dated 26 November 2024, on arrangements for the implementation of an Academic Career Pathways (Research) scheme (*Reporter*, 6761, 2024–25, p. 144) be approved, except that paragraph 7(d)(i) of the Report be amended to read: '(i) the proposal for the scheme to run termly;'.

The Council will consider the proposed amendment at its next meeting on 24 March. The ballot timetable set out in the Notice of 21 February, in which voting was to open on 20 March, is therefore withdrawn.² The Council will publish a revised ballot timetable after its meeting on 24 March.
